**JOINT MOTION TO CONTINUE PROCEDURAL SCHEDULE, INCORPORATED
MEMORANDUM IN SUPPORT, AND REQUEST FOR EXPEDITED TREATMENT**

In accordance with Rules 4901-1-12 and 4901-1-13, Ohio Adm. Code, Complainant Russell Enyart and Respondent Ohio Edison Company (together, the “Parties”) jointly move to continue the procedural schedule in this matter and request expedited treatment of this Motion. Good cause exists to grant this joint Motion and to grant an expedited ruling.

On July 17, 2019, the Attorney Examiner granted Complainant’s unopposed motion for a continuance of the hearing date and set this matter to be heard on November 19, 2019. In that same Order, the Attorney Examiner set October 29, 2019 as the deadline for testimony. Since the Attorney Examiner’s ruling, the Parties have engaged in discovery and filed direct testimony. The Parties respectfully request, however, that the November 19 hearing date be continued. The Parties wish to engage in further discovery, including depositions, and the schedules of counsel and the Parties’ respective witnesses cannot accommodate such discovery prior to the currently scheduled hearing date. Moreover, the Parties wish to further explore the potential for settlement of this matter.

The Parties thus request that the hearing date be continued indefinitely, with the Parties to file a status update by January 31, 2020. In that status update, the Parties would advise the

Commission as to whether a hearing is still necessary, and if so, suggest dates on which the hearing could take place.

With the November 19 hearing only seven days away, the Parties request an expedited ruling on this Motion under Rule 4901-1-12(C). Given the joint nature of this Motion, no party objects to the issuance of an expedited ruling without the filing of memoranda, as certified by the signatures of the undersigned counsel.

For these reasons, the Parties request that the Commission grant this Motion and their request for an expedited ruling.
