On August 28, 2014, MPower Energy NJ, LLC ("Company") filed an Application for a License to Supply Electricity or Electric Generation Services in Maryland under COMAR 20.51. Additional information was filed on December 10, 2014 and February 4, 2015.

Furthermore, the Company's website shall also include a disclaimer that MPower Energy, LLC is not affiliated with the State of Maryland's EmPOWER Maryland program.

Finally, the Company is reminded that it is under a continuing obligation to notify the Commission within 30 days of any changes to the information upon which the Commission relied in granting this license. A copy of the supplemental or updated information is required to be filed concurrently with the Office of People's Counsel.



BY THE COMMISSION:

On August 11, 2015 MPower Energy NJ LLC, (MPower), Utility Code 1117947, filed an application seeking to become a licensed electric generation supplier (EGS) in the electric distribution company service territories of PECO Energy Company and PPL Electric Utilities Corporation in the Commonwealth of Pennsylvania. The application was filed pursuant to the Commission's regulations at 52 Pa. Code §§54.31-54.43, which became effective on August 8, 1998, and which were established under Section 2809 of the Public Utility Code, 66 Pa. C.S. §2809.

§2809 provides in pertinent part that:

License Requirement.--No person or corporation, including municipal corporations which choose to provide service outside their municipal limits except to the extent

provided prior to the effective date of this chapter, brokers and marketers, aggregators and other entities, shall engage in the business of an electric generation supplier in this Commonwealth unless the person or corporation holds a license issued by the Commission. 66 Pa. C.S. §2809.

An electric generation supplier is defined as:

A person or corporation, including municipal corporations which choose to provide service outside their municipal limits except to the extent provided prior to the effective date of this chapter, brokers and marketers, aggregators or any other entities, that sells to end-use customers electricity or related services utilizing the jurisdictional transmission or distribution facilities of an electric distribution company, or that purchases, brokers, arranges or markets electricity or related services for sale to end-use customers utilizing the jurisdictional transmission and distribution facilities of an electric distribution company. 66 Pa. C.S. §2803.

MPower is a foreign limited liability company, formed in the State of New Jersey as of December 11, 2012, and registered to do business in the Commonwealth of Pennsylvania on February 25, 2015. MPower proposes to act as a supplier of retail electric power to residential, small commercial (25 kw and under demand), and large commercial (over 25 kw demand) customers.

Regarding the financial and technical requirements of the license application, MPower has submitted two years of financial statements, a tax return, and a bank letter. MPower has also supplied extensive resume data for its chief officer, its previous experience in the energy industry, its business plan and its oversight of marketing plan. MPower is also applying for an NGS license, at Docket Number A-2015-2497872, and is being considered at this same Public Meeting. We find that sufficient information has been provided by MPower to demonstrate its financial and technical fitness in order to be licensed as a supplier of retail electric power in the Commonwealth of Pennsylvania.

Since MPower will be providing electric generation supplier services to residential customers it is required to comply with, and be governed by, applicable Chapter 56 residential service regulations as set forth in the Commission Order Guidelines for Maintaining Customer Service at the Same Level of Quality Pursuant to 66 Pa. C.S. §2807(d), and Assuring Conformance with 52 Pa. Code Chapter 56 Pursuant to 66 Pa. C.S. §2809(e) and (f), at Docket No. M-00960890 F0011, Order entered July 11, 1997. Thus, we deem it appropriate to reiterate certain items with respect to Chapter 56 of our regulations. Chapter 56 (52 Pa Code Chapter 56) is applicable to residential accounts. An electric generation supplier cannot physically disconnect a residential customer from the electricity grid; therefore, the rules relating to residential service termination are not applicable to electric generation suppliers. An electric generation supplier may seek to terminate its generation service through an appropriate written notice to the customer and the distribution company. The residential customer can then attempt to repair their relationship with the supplier, seek a new supplier, or return to utility service at default service rates in accordance with the utility's obligations under Section 2807(e), 66 Pa. C.S. §2807(e). The customer would only be disconnected from the electricity grid pursuant to appropriate regulations if the customer failed to meet its obligations to the utility or the electric generation supplier that has been designated by the Commission as the provider of last resort.

Additionally, we specifically note that the licensee must comply with, and ensure that its employees, agents, representatives and independent contractors comply with the standards of conduct and disclosure for licensees set out in Commission regulations at 52 Pa. Code §54.43 that were enacted to protect consumers of this Commonwealth. These standards include, *inter alia*, the provision of timely and accurate information about the services offered by the licensee, the practice of nondiscrimination in service in regard to race, color, religion, national origin, marital status, etc., the safeguarding of a consumer's personal information, and compliance with applicable state and federal consumer protection laws. We further note that the licensee and its agents must comply with the Commission's

sales and marketing regulations at 52 Pa. Code §111.1, et seq. applicable to residential customers. Among other things, these regulations require the licensee and its agents to provide accurate information about products and services being offered and prohibit a licensee and its agents from engaging in misleading or deceptive conduct and from making false or misleading representations. Also, we take this opportunity to remind the licensee of its agreement to abide by, and to ensure that its employees, representatives, agents and independent contractors abide by all applicable federal and state laws, and Commission regulations, procedures and orders, including Emergency Orders, which may be issued verbally or in writing during any emergency situations that may unexpectedly develop from time to time in the course of doing business in Pennsylvania.

We also note that that the licensee must comply with our decision in Docket No. M-2010-2157431, Motion adopted at the February 11, 2010, Public Meeting, regarding EGS membership in the PJM Interconnection (PJM). Specifically, our Motion directed that such EGS applicants must file with the Commission, within 120 days of receiving an EGS license, proof of membership in the PJM as a Load Serving Entity (LSE) or proof of a contractual arrangement with an existing PJM LSE that facilitates the applicant's retail operations. Since MPower is taking title to electricity, it is required to comply with this requirement, and has provided proof of approved PJM Membership as an LSE as of February 21, 2013.

Finally, should MPower employ any independent consultants to arrange for the sale of its energy products to end-users, it must inform such independent consultants that they will be required to be licensed as an EGS if they arrange for the sale of energy products to end-users from another supplier or suppliers in addition to MPower.

MPower has provided proofs of publication in the Pennsylvania newspapers and proofs of service to the interested parties as required by the Commission.

MPower has provided a \$250,000 surety bond as required by the license application.

As of March 1, 2016, no protests have been filed.

We find that the applicant:

- 1. Is fit, willing and able to properly perform the service proposed in conformance with applicable provisions of the Public Utility Code and lawful Commission orders and regulations, specifically including 52 Pa. Code Chapter 56 (relating to Standards and Billing Practices for Residential Utility Service).
- 2. Has agreed to lawfully abide by all Commission regulations, procedures and orders, including Emergency Orders, which may be issued verbally or in writing during any emergency situations that may unexpectedly develop from time to time in the course of doing business in Pennsylvania.
- 3. That the proposed service, to the extent authorized by the license, will be consistent with the public interest and the policy declared in the Electricity Generation Customer Choice and Competition Act.

Upon full consideration of all matters of record, we find that approval of this application is necessary and proper for the service, accommodation and convenience of the public; THEREFORE,

- 2. 

ORDER

BY THE COMMISSION:

On August 11, 2015, MPower Energy NJ, LLC (MPower), Utility Code 1217948, filed a License Application to provide natural gas supply services in the natural gas distribution company (NGDC) service territories of UGI Utilities, Inc., PECO Energy Company, Philadelphia Gas Works, and Columbia Gas of Pennsylvania, Inc., within the Commonwealth of Pennsylvania. This application was filed pursuant to section 2208 of the Natural Gas Choice and Competition Act (Act) and Title 52 of the Pennsylvania Code, Chapter 62, Subchapter D.

§2208 provides in pertinent part that:

Requirements for Natural Gas Suppliers.--No entity shall engage in the business of a natural gas supplier unless it holds a license issued by the

Commission. To the extent that a natural gas distribution company provides natural gas supply service outside of its chartered or certificated territory, it also must hold a license. A license shall not be required for customers who make de minimis incidental sales or resales to themselves, an affiliate or to other nonresidential retail gas customers. 66 Pa. C.S. §2208.

A natural gas supplier is defined as:

An entity other than a natural gas distribution company, but including natural gas distribution company marketing affiliates, which provides natural gas supply services to retail gas customers utilizing the jurisdictional facilities of a natural gas distribution company. The term includes a natural gas distribution company that provides natural gas supply services outside its certificated service territories. The term includes a municipal corporation, its affiliates or any joint venture, to the extent that it chooses to provide natural gas supply services to retail customers located outside of its corporate or municipal limits, as applicable, other than:

- (i) as provided prior to the effective date of this chapter, pursuant to a certificate of public convenience if required under this title;
- (ii) total natural gas supply services in de minimis amounts;
- (iii) natural gas supply services requested by, or provided with the consent of, the public utility in whose certificated territory the services are provided; or
- (iv) natural gas supply services provided to the municipal corporation itself or its tenants on land it owns or leases, or is subject to an agreement of sale or pending condemnation, as of September 1, 1999, to the extent permitted by applicable law independent of this chapter.

The term excludes an entity to the extent that it provides free gas to endusers under the terms of an oil or gas lease. Notwithstanding any other provision of this title, a natural gas supplier that is not a natural gas distribution company is not a public utility as defined in section 102 (relating to definitions) to the extent that the natural gas supplier is utilizing the jurisdictional distribution facilities of a natural gas distribution company or is providing other services authorized by the Commission. 66 Pa. C.S. § 2202.

As used in the above definition of a natural gas supplier, the term natural gas supply services includes: (i) the sale or arrangement of the sale of natural gas to retail customers; and (ii) services that may be unbundled by the Commission under section 2203(3) of the Act (relating to standards for restructuring of the natural gas utility industry). Natural gas supply service does not include distribution service. 66 Pa. C.S. § 2202.

We find that sufficient information has been provided by MPower to demonstrate its financial and technical fitness in order to be licensed as a NGS in the Commonwealth of Pennsylvania.

Chapter 56 (52 Pa Code Chapter 56) is applicable to residential accounts. A natural gas supplier cannot physically disconnect a residential customer from the distribution system, and thus, the rules relating to residential service termination are not applicable to natural gas suppliers. A natural gas supplier may seek to terminate its natural gas services through an appropriate written notice to the customer and the local distribution company. The residential customer can then attempt to repair his or her relationship with the natural gas supplier, seek a new natural gas supplier, or default to the natural gas distribution company's service tariffed rates in accordance with the local distribution company's obligations under Section 2207(a), 66 Pa. C.S. §2207(a). The customer would only be disconnected from the distribution system pursuant to appropriate regulations if the customer failed to meet his or her obligations to the natural gas distribution company or the natural gas supplier which has been designated by the Commission as the supplier of last resort.

Section 2208(c)(1), 66 Pa. C.S. §2208(c)(1), provides that a natural gas supplier license shall not be issued unless the applicant furnishes a bond or other security in a form and amount to ensure its financial responsibility. The criteria used to establish the form and amount of the bond or other security is set forth in the natural gas distribution company's tariff. The amount and form of the bond or other security may also be mutually agreed to between the natural gas distribution company and the natural gas supplier. Section 2208 also provides that should the parties fail to achieve an agreement, then the form and amount of bond or other financial security "shall be determined by criteria approved by the Commission." MPower has provided documentation to evidence its compliance with the Section 2208(c) bonding requirement for the NGDC service territories of UGI Utilities, Inc., PECO Energy Company, Philadelphia Gas Works, and Columbia Gas of Pennsylvania, Inc., within the Commonwealth of Pennsylvania.

I. <u>INTRODUCTION</u>

1. By this Order, the Public Service Commission of the District of Columbia ("Commission") grants a license to MPower Energy NJ LLC ("MPower" or "Applicant") to function as an electricity supplier in the District of Columbia. MPower Energy NJ LLC's license is effective upon issuance of this Order.

II. BACKGROUND

- 2. On February 16, 2017, MPower filed its license application.² Specifically, MPower intends to operate as a marketer of electricity for residential and commercial customers in the District of Columbia, pursuant to Section 34-1505 of the "Retail Electric Competition and Consumer Protection Act of 1999 ("Act")." Pursuant to the Commission's licensing requirements as set forth in Order No. 11796,⁴ MPower has provided the following information:
 - a) Proof of technical and managerial competence;
 - b) An affidavit of compliance with applicable Federal and District of Columbia environmental laws and regulations dated January 24, 2017;
 - c) Proof of financial integrity to include financial statements;

d) Proof that MPower has registered with the Department of Consumer and Regulatory Affairs to do business in the District of Columbia;

- e) An affidavit dated January 24, 2017, stating that MPower is subject to all applicable taxes;
- f) An affidavit dated January 24, 2017, stating that MPower will comply with all the requirements of all orders and regulations of the Commission; and
- g) Applicant's website address: http://www.mpowerenergy.com.

III. <u>DISCUSSION</u>

3. Our review of the information contained in MPower's application, demonstrates that it has met all the prescribed licensing requirements and that the Applicant has the ability and the financial integrity to serve electricity customers in the District of Columbia. The Commission also finds that granting MPower's application will serve the public interest. Accordingly MPower's application is approved.

I. <u>INTRODUCTION</u>

1. By this Order, the Public Service Commission of the District of Columbia ("Commission") grants a license to MPower Energy NJ LLC ("MPower" or "Applicant") to operate as a natural gas supplier in the District of Columbia. MPower Energy NJ LLC's license is effective upon the issuance of this Order.

II. BACKGROUND

- 2. On May 25, 2017, MPower filed its license application. ² Specifically, MPower intends to operate as a marketer of natural gas for distribution to residential and commercial customers in the District of Columbia. Pursuant to the Commission's licensing requirements as set forth in Order Nos. 12709 and 12903 in GT 96-3,³ MPower provided the following information:
 - a) Proof of technical and managerial competence;
 - b) Affidavit dated April 27, 2017, affirming compliance with applicable Federal and District of Columbia environmental laws and regulations;
 - c) Proof of financial integrity including financial statements;
 - d) Proof that MPower registered with the Department of Consumer and Regulatory Affairs to do business in the District of Columbia:
 - e) Affidavit dated April 27, 2017, stating that MPower is subject to all applicable taxes;

f) Affidavit dated April 27, 2017, stating that MPower will comply with all the requirements of all orders and regulations of the Commission; and

g) Applicant's website address: www.mpowerenergy.com.

III. <u>DISCUSSION</u>

3. Our review of the information contained in MPower's application demonstrates that it has met all the prescribed licensing requirements and that the Applicant has the ability and the financial integrity to serve natural gas customers in the District of Columbia. The Commission also finds that granting MPower's application will serve the public interest. Accordingly MPower Energy NJ LLC's application is approved.

THEREFORE, IT IS ORDERED THAT:

I. INTRODUCTION AND PROCEDURAL HISTORY

On October 19, 2017, MPower Energy NJ LLC ("Applicant") filed a verified application with the Illinois Commerce Commission ("Commission") to operate as an alternative retail electric supplier ("ARES") in Illinois pursuant to Section 16 115 of the Public Utilities Act ("Act"), 220 ILCS 5/1-101 et seq., and 83 III. Adm. Code 451 ("Part 451"). Applicant requests a certificate of service authority to serve all eligible residential and nonresidential retail customers in the service territory of Commonwealth Edison Company ("ComEd"), under Subpart D of Part 451. Applicant filed an Amended Application and a Verified Response to Administrative Law Judge's Ruling ("Response") on November 17, 2017. Applicant also submitted its certificate of publication showing that on November 21, 2017 notice of the application was published in the official State newspaper.

II. BACKGROUND AND AUTHORITY SOUGHT BY APPLICANT

Applicant is a New Jersey limited liability company ("LLC"). Applicant requests a certificate of authority to operate as an ARES under subpart D of Part 451, serving all eligible electric customers, in the service territory of ComEd. Applicant states that it has notified the designated agent of ComEd that it seeks a certificate to offer the sale of electricity and power to all eligible residential and nonresidential retail customers in its service territory.

Applicant is not affiliated with an Illinois utility. Applicant does not currently have authority to operate as an ARES in Illinois. Applicant indicates it operates as an alternative electric and gas supplier in New Jersey, Maryland, and Pennsylvania. Applicant is licensed as an alternative electric supplier in Ohio and the District of Columbia. Applicant has a license to be an alternative gas supplier pending in Ohio. Applicant states it has an affiliate, MPower Energy LLC, that is licensed as a retail electric suppler in New York.

Applicant does not intend to provide single billing services. The Applicant certifies that neither it, nor its affiliate have had any formal complaints filed against it. Applicant indicates that informal complaints have been filed against it in New Jersey and against its

affiliate, MPower Energy LLC, in New York. Applicant states that all informal complaints have been resolved. Applicant indicates that no complaints of any kind have been filed against it in Maryland or Pennsylvania. Applicant asserts it has not been denied an electric supplier license, nor has it had an electric supplier license suspended or revoked by any state.

III. REQUIREMENTS UNDER SECTION 16-115 OF THE ACT

A. General

Applicant has certified that it will comply with all applicable regulations; provide service only to retail customers eligible to take such services; and comply with informational and reporting requirements established by Commission rule. Applicant certifies that it will comply with all the terms and conditions required by Section 16-115A(c) of the Act. Applicant asserts that it will comply with all other applicable Federal, State, regional and industry rules, practices, policies, procedures and tariffs for the use, operation, maintenance, safety, integrity, and reliability of the interconnected electric transmission system. Applicant has certified compliance with all terms and conditions required by Sections 16-115A(a), (b), and (f), 16-119, 16-123, 16-125(b) and (c), 16-127, and 16-128(a) of the Act to the extent those Sections have application to the services it will offer.

Applicant has agreed to submit good faith schedules of transmission and energy in accordance with applicable tariffs. Applicant certifies that it will provide for review by Commission Staff, on a confidential basis, data related to contracts for the purchase and sale of electric power and energy. Applicant has agreed to adopt and follow rules relating to customer authorizations, billing records, and requests for retail electric services and agrees to retain requests for delivery services transmitted to utilities for a period of not less than two calendar years after the calendar year in which they are created. Applicant has agreed to adopt and follow rules and procedures to preserve the confidentiality of its customers' data.

Applicant certifies that it will procure renewable energy resources as required by Section 16-115D and subsection (d) of Section 16-115 of the Act. Applicant certifies that it will source electricity from clean coal facilities as required by Section 16-116(d)(5) of the Act. Applicant states that it will not use electric generation, transmission or distribution facilities that it owns, controls or operates in serving customers.

Pursuant to the requirements of Subpart D of Part 451, Applicant certifies that any marketing materials that make statements concerning prices, terms and conditions of service will contain information that adequately discloses the prices, terms and conditions of the products or services that it is offering or selling to the customer. Applicant certifies that before any customer is switched from another supplier, it will give the customer written information that adequately discloses, in plain language, the prices, terms and conditions of the products and services being offered and sold to the customer. Applicant certifies that it will provide documentation to the Commission and to customers that substantiates any claims made regarding the technologies and fuel types used to generate the electricity offered or sold to customers. Applicant commits to provide to its customers itemized billing statements that describe the products and services provided

to the customer and their prices; and an additional statement, at least annually, that adequately discloses the average monthly prices, and the terms and conditions, of the products and services sold to the customer.

Applicant certifies that it will include materials comprising the consumer education program pursuant to Section 16-117 of the Act with all initial mailings to potential residential and small commercial retail customers and before executing any agreements or contracts with such customers. Applicant certifies that it will also provide, upon request, consumer education program materials pursuant to Section 16-117 of the Act, at no charge to residential and small commercial retail customers. Applicant certifies that it will provide to residential and small commercial retail customers on a semi-annual basis information on how to obtain a list of alternative retail electric suppliers that have been found in the last three years by the Commission to have failed to provide service in accordance with the terms of their contracts pursuant to Section 16-117(g)(4)(C) of the Act.

The Applicant agrees that in the event the Applicant bills any residential customer directly for supply, the Applicant shall ensure that when marketing to residential customers who receive any type of low income energy assistance, the Applicant has entered into the necessary agreements to allow low-income customers to receive Low Income Home Energy Assistance Program ("LIHEAP") benefits and Percentage of Income Payment Plan ("PIPP") benefits. In the event that the Applicant is granted Commission authorization to provide supplier single billing to residential customers, the Applicant shall ensure that, when marketing to residential customers who receive any type of low-income energy assistance, the Applicant has entered into the necessary agreements to allow low-income customers to receive LIHEAP benefits and PIPP benefits.

B. Financial, Technical, and Managerial

In Attachment E, Applicant certifies it is a member of the PJM Regional Transmission Organization ("RTO") and purchases 100% of its physical electric energy from the RTO for delivery to the service territories of the utilities for which the Applicant is seeking a certificate. To demonstrate its membership to the appropriate RTO, Applicant provides a print out from PJM's website demonstrating that MPower Energy NJ LLC is a member of PJM (as of 10/16/17).

Applicant asserts that it has obtained a license or permit bond as required by Section 451.50. Applicant states that a copy of its license or permit bond is attached to the Application as Attachment No. 3. The amount of the bond complies with Section 451.50.

Applicant represents that it meets the technical and managerial qualifications set forth in Section 16-115(d)(1) of the Act and Sections 451.230 and 451.240 of Part 451. Applicant provides information regarding the technical and managerial qualifications of Applicant's staff in a Response to the Administrative Law Judge's Ruling. Applicant attached a corporate organizational chart to its Response. Applicant provides a telephone number and facsimile number through which it states a staff member can be reached at all times. Applicant states that it is not relying on agents or contractors to meet the technical and managerial requirements of Part 451.230 and 451.240.

IV. COMMISSION ANALYSIS AND CERTIFICATE OF SERVICE AUTHORITY

The Commission has reviewed the Application, Amended Application, and attachments along with its Verified Responses regarding the technical, financial, and managerial requirements and all other requirements of the Act and Part 451. The Commission finds that the Applicant sufficiently demonstrates compliance with the Part 451 requirements.

Applicant does not intend to offer single billing services. In the event that the Applicant is granted authorization to provide supplier single billing to residential customers, the Applicant shall ensure that, when marketing to residential customers who receive any type of low-income energy assistance, the Applicant has entered into the necessary agreements to allow low-income customers to receive LIHEAP benefits and PIPP benefits. It is noted that no demonstration of compliance with the requirements of Section 451.20(d)(2) has been made and Applicant's employees are not permitted to perform such functions, and other entities are not permitted to perform such functions pursuant to contractual arrangements with Applicant.

The Commission concludes, therefore, that Applicant's request for a certificate of service authority to operate as an ARES in Illinois should be granted and should include the following authority:

CERTIFICATE OF SERVICE AUTHORITY

IT IS CERTIFIED that MPower Energy NJ LLC is granted service authority to operate as an Alternative Retail Electric Supplier as follows:

SERVICE TO BE PROVIDED: The sale of electricity and power.

PRIMARY CUSTOMER CLASS TO BE SERVED: All eligible residential and non-residential customers.

GEOGRAPHIC REGIONS SERVED: The service area of Commonwealth Edison Company.

V. FINDINGS AND ORDERING PARAGRAPHS

The Commission, having reviewed the entire record, is of the opinion and finds that:

- (1) Applicant, MPower Energy NJ LLC, a limited liability company organized under the laws of New Jersey, seeks a certificate of service authority to operate as an alternative retail electric supplier under Section 16-115 of the Act;
- (2) the Commission has jurisdiction over the Applicant and the subject matter hereof;
- (3) the facts recited and conclusions reached in the prefatory portion of this Order are supported by the record and are hereby adopted as findings of fact as required by Section 16-115(d) of the Act;

- (4) Applicant has demonstrated that it possesses sufficient financial, managerial and technical resources and abilities to provide power and energy to residential and non-residential customers throughout the service area of Commonwealth Edison Company;
- (5) Applicant has complied with Section 16-115(d)(1) through (5) and (8) of the Act and 83 III. Adm. Code 451; and
- (6) MPower Energy NJ LLC should be granted a certificate of service authority to operate as an alternative retail electric supplier as specified in Section IV of this Order.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that MPower Energy NJ LLC is hereby granted a Certificate of Service Authority as set forth in Section IV of this Order.

IT IS FURTHER ORDERED that MPower Energy NJ LLC shall comply with all applicable Commission rules and orders now and as hereafter amended.

IT IS FURTHER ORDERED that, subject to the provisions of Section 10-113 of the Public Utilities Act and 83 III. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.

I. INTRODUCTION AND PROCEDURAL HISTORY

On October 19, 2016, MPower Energy NJ LLC ("Applicant") filed a verified application with the Illinois Commerce Commission ("Commission") requesting a certificate of service authority as an alternative gas supplier ("AGS") in Illinois pursuant to Section 19-110 of the Public Utilities Act ("Act"), 220 ILCS 5/1-101 et seq., and 83 Ill. Adm. Code 551 ("Part 551"). Applicant requests a certificate of service authority to serve residential and small commercial customers in the service areas of Northern Illinois Gas Company d/b/a Nicor Gas Company ("Nicor"), The Peoples Gas Light and Coke Company ("Peoples"), and North Shore Gas Company ("North Shore"). Applicant submitted its certificate of publication showing that on November 2, 2017 notice of the Application was published in the official State newspaper, pursuant to Section 19-110(c) of the Act and Section 551.30(a). On November 17, 2017, Applicant filed an Amended Application and a verified Response to an Administrative Law Judge ("ALJ") Ruling, providing additional information and updating certain information in the original Application.

II. DESCRIPTION OF AND AUTHORITY SOUGHT BY APPLICANT

Applicant is a limited liability company, formed under the laws of the State of New Jersey. Applicant provides documentation from the Office of the Secretary of State, State of Illinois, demonstrating that Applicant has been approved to transact business in the State of Illinois. Applicant is an alternative retail electric supplier ("ARES") and AGS engaged in the contracting for the purchase of electricity and natural gas for retail sale, scheduling of retail electricity and natural gas for delivery to residential and commercial customers. Applicant indicates that it engages in various methods to market energy to consumers, including in-person and telephonic sales.

Applicant seeks a certificate to offer the sale of natural gas to residential and small commercial customers in the Nicor, Peoples, and North Shore service territories. A copy of the notification sent to each of these companies has been provided, pursuant to Section 551.30(c). Applicant does not seek to serve customers within a geographic area that is smaller than a gas utility's service territory. Applicant does not currently have authority to

operate as an AGS in Illinois. Applicant states that it provides both gas and electricity service.

III. AGS REQUIREMENTS AND OBLIGATIONS

As required by Section 551.20(a) of Part 551, Applicant certifies that it will comply with all Federal, State, regional and industry rules practices, policies, procedures, and tariffs for the use, operation, maintenance, safety, integrity, and reliability of the interstate natural gas system. Applicant states it will submit good faith schedules of natural gas deliveries in accordance with applicable tariffs. Applicant certifies that it will comply with all applicable terms and conditions required by Section 19-110 of the Act. Applicant also certifies that it will provide service to eligible commercial and residential customers in the Nicor, Peoples, and North Shore service. Applicant asserts it will serve residential and small commercial customers who are eligible to take service from an AGS; that it will comply with informational and reporting requirements established by Commission rule; and that it will comply with all other applicable laws and regulations and Commission rules and orders pursuant to Section 551.20.

Applicant indicates it has not been denied a natural gas license in any state in the United States. Applicant states it has never had a natural gas supplier license suspended or revoked by any state in the United States. Applicant indicates it operates as an alternative electric and gas supplier in New Jersey, Maryland, and Pennsylvania. Applicant is licensed as an alternative electric supplier in Ohio and the District of Columbia. Applicant has a license to be an alternative gas supplier pending in Ohio. Applicant states that it is not the subject of any lawsuits filed in a court of law or formal complaints alleging fraud, deception, or unfair marketing practices or other similar allegations.

Applicant intends to offer retail supply of electricity and natural gas to both residential and commercial customers without limits on size or usage requirements. In accordance with Section 551.40, Applicant agrees to adopt and follow rules and procedures ensuring that authorizations received from customers, customer billing records, and requests for service transmitted to utilities are retained for a period of not less than two calendar years after the calendar year in which they were created. In addition, Applicant agrees to adopt and follow rules to preserve the confidentiality of customer data.

Applicant certifies that all marketing materials that make statements concerning prices, terms, and conditions of service shall contain information that adequately discloses the prices, terms, and conditions of the products or services that it is offering or selling to the residential or small commercial customer. Applicant agrees that before any customer is switched from another supplier, the Applicant will give the customer written information that adequately discloses, in plain language, the prices, terms, and conditions of the products and services being offered and sold to the customer.

Applicant certifies that it will provide to the residential customer accurate, timely, and itemized billing statements that describe the products and services provided to the customer and their prices and that specify the gas consumption amount and any service charges and taxes; and an additional statement, at least annually, that adequately

discloses the average monthly prices, and the terms and conditions, of the products and services sold to the residential customer.

Applicant certifies it will provide refunds of any deposits with interest, at a rate set by the Commission which shall be the same as that required of gas utilities, within 30 days after the date that the residential or small commercial customer changes gas suppliers or discontinues service if the customer has satisfied all of its outstanding financial obligations to it. Applicant also agrees to provide timely refunds of any undisputed overpayments upon oral or written request of the small commercial or residential customer.

Applicant certifies that it will maintain procedures addressing the manner in which any disputed amount for which a residential or small commercial customer is billed, may be resolved. Applicant states that while the dispute is pending, the customer shall pay the undisputed portion of the bill or an amount equal to last year's bill at the same location for the same period, normalized for weather, whichever is greater. Applicant affirms that any disputed amount in excess of last year's bill for the same address adjusted for weather shall not be included in the amount that must be paid by the due date. Applicant also agrees to inform its customers how to contact the Commission's Consumer Services Division to pursue an unresolved dispute. Applicant agrees to inform its small commercial and residential customers how to contact the Commission to obtain consumer education materials provided pursuant to Section 19-125 of the Act.

MPower Energy NJ LLC certifies in the event that the applicant bills any residential customer directly for supply, the Applicant shall ensure that when marketing to residential customers who receive any type of low income energy assistance, the applicant has entered into the necessary agreements to allow low-income customers to receive Low Income Home Energy Assistance Program ("LIHEAP") benefits and Percentage of Income Payment Program ("PIPP") benefits. If the Applicant is granted authorization to provide supplier single billing to residential customers, the Applicant will ensure that, when marketing to residential customers who receive any type of low-income energy assistance, the applicant has entered into the necessary agreements to allow low-income customers to receive LIHEAP and PIPP benefits.

MPower Energy NJ LLC certifies its commitment of resources to the management of sales and marketing staff, through affirmative managerial policies, independent audits, technology, hands on field monitoring and training, and, in the case of any sales personnel or sales agents, within the State of Illinois, the Applicant's managerial presence within the State.

Applicant provides a copy of its license or permit bond, as required by Section 551.50 as Attachment 1 to the Amended Application. The bond was issued by Great American Insurance Company, a Ohio Corporation, authorized to do business in the State of Illinois. The amount of the bond complies with Section 551.50(a).

Applicant asserts that it meets the financial criteria set forth in Section 551.80(a). It presents its certified financial statements for the revolving credit agreement as required under subsection 551.80(g) in Attachment 4 to the Application. Applicant provides additional information in its Response to the ALJ's Ruling.

Applicant submits that it meets the "Technical Qualifications" and "Managerial Qualifications" which are set forth in Sections 551.90 and 551.100, respectively. With the Response to the ALJ Ruling, Applicant provides information regarding the "persons being used" to meet the requirements of those sections, including an organizational chart, a narrative describing the individual's technical and managerial qualifications. Applicant certifies that it will commit resources to the management of sales and marketing staff, through affirmative managerial policies independent audits, technology, hands on field monitoring and training, and, in the case of any sales personnel or sales agents, a managerial presence within the State.

IV. COMMISSION ANALYSIS AND CONCLUSION

The Commission has reviewed the Application, the Response to ALJ Ruling, and all Attachments. Subject to the conditions contained herein, the Commission finds that the Application is in order and satisfies the requirements of the Act and Part 551. Applicant has demonstrated that it possesses sufficient financial, technical, and managerial resources and abilities to provide the sale of natural gas service to eligible residential and small commercial retail customers. The Commission observes that the requirements of Sections 551.50(b) and (c) remain fully applicable to the Applicant. The Commission concludes, therefore, that the application for certification as an AGS should be granted as follows:

CERTIFICATE OF SERVICE AUTHORITY

IT IS CERTIFIED that MPower Energy NJ LLC is granted service authority to operate as an Alternative Gas Supplier as follows:

SERVICE TO BE PROVIDED: The sale of natural gas.

PRIMARY CUSTOMER CLASS TO BE SERVED: All eligible small commercial customers.

GEOGRAPHIC REGIONS SERVED: The service areas of Northern Illinois Gas Company d/b/a Nicor Gas Company, The Peoples Gas Light and Coke Company, and North Shore Gas Company.

SECONDARY CUSTOMER CLASS TO BE SERVED: All eligible residential and small commercial customers.

GEOGRAPHIC REGIONS SERVED: The service areas of Northern Illinois Gas Company d/b/a Nicor Gas Company, The Peoples Gas Light and Coke Company, and North Shore Gas Company.

V. FINDINGS AND ORDERING PARAGRAPHS

The Commission, having reviewed the entire record, is of the opinion and finds that:

- (1) Applicant, which is a limited liability company organized and existing under the laws of New Jersey, is licensed to do business in the State of Illinois and seeks authority to operate as an AGS under Section 19-110 of the Act;
- (2) the Commission has jurisdiction over the Applicant and the subject matter hereof;
- (3) the facts recited and conclusions reached in the prefatory portion of this Order are supported by the record and are hereby adopted as findings of fact:
- (4) as required by Section 19-110(e)(1) of the Act, Applicant possesses sufficient technical, financial, and managerial resources and abilities to provide natural gas service to eligible customers throughout the areas certificated herein;
- (5) Applicant shall comply with Section 19-110(e)(2), (3), (4), and (5) of the Act; and
- (6) Applicant should be granted a Certificate of Service Authority as set out above, and shall thereafter comply with all applicable Commission rules and orders and any applicable amendments thereto.

IT IS THEREFORE ORDERED by the Commission that subject to the conditions set forth herein, MPower Energy NJ LLC is hereby granted a Certificate of Service Authority as an alternative gas supplier, as set forth in Section IV of this Order.

IT IS FURTHER ORDERED that MPower Energy NJ LLC shall comply with all applicable Commission rules and orders now in effect and as hereafter amended.

IT IS FURTHER ORDERED that, subject to the provisions of Section 10-113 of the Public Utilities Act and 83 III. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.

Mpower Energy NJ LLC provides gas service to 14,000 residential customers and electric service to 11,000 residential customers. Although the two companies are not legally affiliated, they share all managerial staff and the bulk of our experience has been gained in New York where the company started in 2009. In New York State MPower Energy LLC currently provides gas services to over 40,000 residential customers and 500 commercial customers, and electric service to over 50,000 residential customers and 2,000 commercial customers.

In addition MPower Energy NJ has a full staff of in-house customer service representatives who are trained to answer any inquires or complaints that our customers may have.

*Percentage of on-time payments by month.









'Corporate Structure'

MPower Energy NJ LLC is currently licensed to provide retail gas and electric services by the New Jersey Board of Public Utilities, the Maryland Public Service Commission, the Pennsylvania Public Utility Commission, the Public Service Commission of the District of Columbia, the Public Utilities Commission of Ohio, and the Illinois Commerce Commission. This application's purpose is to renew MPower Energy NJ LLC's registration with the Public Utilities Commission of Ohio. In Maryland, the company operates under the DBA MPE&G LLC. There is a second commonly owned company, MPower Energy LLC, an affiliate. MPower Energy LLC is a licensed to provide retail gas and electric services by the New York Public Service Commission and is pending licensure by the Public Utilities Regulatory Authority of Connecticut. The same owners of MPower Energy NJ LLC, Joseph and Lavie Popack, own Mpower Energy LLC.



Operations & Operations Expertise

MPower Energy NJ LLC's operations in New Jersey, Pennsylvania, Maryland, Ohio, Illinois, and the district of Columbia, currently include the retail sale of electricity and natural gas to residential and commercial customers, the contracting for electricity and natural gas for retail sale, and the nomination and scheduling of electricity and natural gas for delivery to retail customers. This will be part of the operational nature of its business in Ohio as well.

MPower Energy NJ LLC is constantly striving to improve its operations and engages in extensive oversight of its sales agents' retail energy marketing activities. MPower Energy NJ LLC dedicates significant resources toward quality, oversight and compliance. In an effort to improve its services, MPower Energy NJ LLC's policies and procedures evolve on a continual basis in response to customer feedback, regulatory agency feedback, changes in regulations and technology, and staff meetings and brainstorming sessions. Additionally, MPower Energy NJ LLC views each customer complaint as a call to action and policy change. MPower Energy NJ LLC has dedicated careful attention to company branding in an effort to curb customer misunderstanding and agent misrepresentation. MPower Energy NJ LLC agents go into the field with prominently-branded photo-ID badges which they must wear during all consumer interactions, including at all times while marketing in the field. MPower Energy NJ LLC agents are further required to wear buttons stating that MPower is "not the utility." This leaves no room for customers to confuse MPower Energy NJ LLC with their current electric/gas utility company. Additionally, MPower Energy NJ LLC agents are required to provide all prospective customers a bill or rights which clearly states that neither MPower Energy NJ LLC nor the agent is affiliated with the utility and that the customer is under no obligation to purchase services from MPower

Energy NJ LLC. MPower Energy NJ LLC has also invested heavily on an extensive "third-party verification" policy that greatly exceeds state-regulatory requirements in all states that MPower Energy NJ LLC is engaged in business. For instance, MPower Energy NJ LLC obtains third-party verification recordings not only for newly-enrolled accounts, but for renewals, extensions and promotions.

Further, all field sales agents used by MPower Energy NJ LLC are employees of a commonly-owned company, MPower Direct LLC. This affords MPower Energy NJ LLC the maximum control and oversight over its agents' activities. All agents are required to come in to MPower Energy NJ LLC's offices for daily morning meetings and to attend weekly training sessions during which compliance requirements or infractions are addressed. Further, all MPower Energy NJ LLC field sales agents are continually monitored in the field by team leaders and supervisors. MPower Energy NJ LLC also monitors its agents in the field using the iknock platform which utilizes geo-locational software to track each agent's location and which flag any enrollment not completed at the physical address of the customer being enrolled. This helps to curb any possibility of unauthorized enrollment (i.e., slamming).

MPower Energy NJ LLC has long recorded all customer interactions, but has recently begun to retain all such recordings. This includes all sales calls, all customer service calls, and all third-party verification ("TPV") calls. The company maintains a staff of approximately one dozen Quality Assurance specialists whose job it is to review sales calls, customer service calls and all TPV calls for in-house and regulatory compliance purposes. No sale is accepted without a TPV recording and MPower Energy NJ LLC's TPV process is administered by live agents employed by an unrelated third party and carefully trained to identify any misunderstanding on

the customer's part, misinformation by the sales agent, or misrepresentation by a minor or person other than the account holder or other authorized person (such as the account holder's spouse). If, at any point, the third-party verification agent identifies anything questionable, the agent is instructed to terminate the call and alert MPower Energy NJ LLC as a preemptive measure against any illegitimate enrollment. MPower Energy NJ LLC also conducts double verification on any accounts flagged by a third-party verification agent, in the case that the enrollment was requested by anyone other than the account holder or spouse or in cases where any discrepancy in the information provided might suggest a problem with the enrollment. MPower Energy NJ LLC agents are rigorously trained according to a strict code of conduct and their transactions are closely overseen by supervisors in the call centers or in the field. For our customers' protection, MPower Energy NJ LLC agents are not permitted to collect any personal or financial information other than the account holder's name, contact information and account number. MPower Energy NJ LLC records all of its sales calls and spot checks the calls.

Simple comments, questions or complaints are handled at the customer service level. MPower Energy NJ LLC's compliance department is responsible for the oversight and resolution of all complaints concerning deceptive marketing, including allegations of slamming, agent misconduct of any kind, do-not-call violations or unauthorized guarantees made by agents (or any complaint for which the customer has requested escalated assistance). In the event of such a complaint, the compliance department first reaches out to the customer to discuss the issue and ensure a clear understanding of what took place and what is required to resolve the situation. Unless the customer has requested otherwise, any account under investigation for compliance violations of any kind would automatically be returned to the utility so as not to allow the

customer to incur any further charges from MPower Energy NJ LLC. Once the charges have been stopped, MPower Energy NJ LLC will pull all available records of interactions with the customer including sales calls, attempted sales calls, paper contracts, customer database notes made by any customer service representatives who assisted them in the past, TPV recordings and knock/call logs. Since steps would have already been taken to reduce or eliminate impact on the customer, at this point the findings of our investigation would mainly be used for internal quality control purposes. Were any gap in our compliance policies revealed, the respective departments would be called upon to take appropriate measures to prevent the issue from recurring. Were it confirmed that an agent willingly and knowingly violated the code of conduct in any way, the agent would be terminated. If no proof could be found that the allegations were true, the agent's record would be noted for future reference. Three complaints of the same or similar nature are considered proof of misconduct and our agents are terminated upon verification of a third complaint. Additionally, MPower Energy NJ LLC has a claw-back policy for all commissions paid out which ensures that there are financial repercussions for violations as well. Upon the completion of an investigation and the administration of all disciplinary measures and operational changes, The company would provide a written report of the findings and the course of action to be taken in response to the regulatory agency that originally submitted the complaint. Where appropriate, the customer would also be given an update.

Additionally, MPower Energy NJ LLC is building its website under the guidance of its legal team to focus on the provision of green energy.
