Dear Ms. Troupe:

On behalf of Ohio Power Company ("AEP Ohio" or the "Company"), I am submitting this filing consistent with the Public Utilities Commission of Ohio's ("Commission") Entry dated October 3, 2018 in Case No. 18-1451-EL-ATA adopting the Stipulation filed in that case. The rate established in the Stipulation requires an update beginning January 2020. Specifically, the current rate includes 14 months of the revenue requirement for the tax expense. Beginning January 2020, the rate will reflect a twelve-month revenue requirement of \$20.4 M per page 6 of the Stipulation.

The Company is attaching its updated Tax Savings Credit Rider rates in compliance with the order approving the Stipulation to become effective with the first billing cycle of 2020.
