This letter serves as The East Ohio Gas Company d/b/a Dominion Energy Ohio's ("Applicant" or "DEO") pre-application notification letter in order for the Ohio Power Siting Board ("Board") to open a case for the Augusta Compressor Station Installation Project East Township, Carroll County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Letter of Notification.

In accordance with Ohio Administrative Code ("OAC") 4906-6-03(A), DEO provides the following information:

**Project Description:** planning to install two 1380 horsepower compressor units and appurtenances to existing Augusta measurement and regulation station. The new compressor units and associated appurtenances will be located on property owned by DEO. The new compressor station will be a bi-direction facility capable of discharging gas for delivery to a third party or capable of delivering gas from third party to DEO.

**Anticipated Project Schedule:** The construction of the new compressor station is anticipated to begin May 2020. DEO plans to place the station in-service by November 2020.
