With respect to the Commission's September 11, 2019 Entry and its August 14, 2019 Entry issued in this proceeding, The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO) files the following request for extension, as described below.

By way of background, the August 14, 2019 Entry directed Staff to issue a request for proposal (RFP) for audit services to assist the Commission with an audit of DEO's Capital Expenditure Program (CEP) and associated CEP costs and deferrals. Among other things, the RFP identified the timeline for the audit, with a final audit report due to be filed with the Commission by February 26, 2020. (RFP at 6.) The September 11, 2019 Entry directed DEO to enter into a contract with Blue Ridge Consulting Services, Inc. (Blue Ridge) for these auditing services.

The RFP also advised that DEO's "legacy fixed-asset reporting system may not permit reporting of CEP versus non-CEP expenditures and assets," and that "a separate data repository is used to provide such reporting." (RFP at 4.) The RFP went on to note that "[f]or this reason, the required emphasis on CEP expenditures and assets may require additional time and/or selections (a) to identify and exclude non-CEP items from fixed-asset-system selections and/or (b) to trace selections from the data repository to the fixed asset system." (*Id.*) Although the RFP stated that the timeline reflected this issue, the RFP contemplated that the timeline "may be revisited and extended," if after conferring the parties determined that "any difficulties or delays are greater than assumed." (*Id.* at 4–5.)

As the RFP contemplated, DEO has despite its best efforts encountered difficulties in dealing with legacy reporting issues, and this has caused delays in producing certain data in response to Blue Ridge data requests. For this reason, DEO is requesting that the Commission approve a 60-day extension of all deadlines reflected in the RFP timeline, with the final audit report to be filed with the Commission by April 27, 2020. Granting this request will permit DEO additional time to fully respond to Blue Ridge's data requests and, in turn, will ensure that Blue Ridge has sufficient time to complete its auditing services. The August 14, 2019 Entry (Paragraph 16) also found that DEO would bear the costs of the audit services solicited in the

RFP; DEO acknowledges that it will bear any costs associated with this extension. DEO does not seek to modify any other terms of the RFP.

DEO discussed its intention to file this request with Staff and Blue Ridge, and neither indicated an objection to DEO's intention to file. DEO expects that Staff will file a recommendation in response.
