MEMORANDUM IN SUPPORT

On December 20, 2019, OCC moved to dismiss this proceeding. Dec. 20, 2019 Motion to Protect Consumers By Denying Dayton Power & Light's Request to Extend Its So-Called Distribution Modernization Rider. By operation of administrative rule, any memorandum in opposition to a motion shall be filed within 15 days. Ohio Adm.Code 4901-1-12(B)(1). In light of the intervening holidays, there is good cause for the Commission to extend the period of time for DP&L to file a memorandum in opposition to OCC's motion by 10 days, *i.e.* until and through January 16, 2020. Ohio Adm.Code 4901-1-13(A).
