**NOTICE OF INTERVENTION AS A PARTY
OF THE
BOARD OF TOWNSHIP TRUSTEES
MILLCREEK TOWNSHIP, UNION COUNTY, OHIO**

The Board of Township Trustees, Millcreek Township, Union County, Ohio was served with the Letter of Notification application of Columbia Gas of Ohio, Inc. for a certificate to construct the proposed Marysville Connector Pipeline Project that will route in part within Millcreek Township, Union County, Ohio. Pursuant to Ohio Revised Code Section 4906.08(A)(2) and Ohio Administrative Code Rule 4906-2-12(A)(1), the Board of Township Trustees, Millcreek Township, Union County, Ohio, gives notice of its intervention and states:

1. The Board of Township Trustees, Millcreek Township, Union County, Ohio, is the duly elected body authorized to act for Millcreek Township, Union County, on matters including land use planning. Because of when the application was filed, and the meeting schedule of the Millcreek Board of Township Trustees the Resolution and other certificates and statements described in Ohio Administrative Code section 4906-2-12 will be submitted within the time provided by law.
2. That the proposed facility, as reflected in the letter of notification application, is to be routed in part in Millcreek Township, Union County, Ohio.
3. The Board of Township Trustees, Millcreek Township, Union County, Ohio intends to intervene because it has interest in the proposed project and proceedings as the elected representatives of the citizens of Millcreek Township, Union County, Ohio. The Board of County Commissioners' interest includes, but is not limited to, land use planning as it relates to the proposed project.

4. The interests of the Board of Township Trustees, Millcreek Township, Union County, Ohio, are not and cannot be represented by another party; the Board of Township Trustees, Millcreek Township, Union County, Ohio will contribute to a just and expeditious resolution; and the Board of Township Trustees, Millcreek Township, Union County, Ohio will not unduly delay the proceedings or unjustly prejudice any party.
