You are receiving this letter because you own property or live in the area that's part of AEP Ohio's Coal Township 138-kilovolt (kV) Transmission Line Rebuild Project, also known as the Pine Ridge Switch-Heppner 138-kV Transmission Line Project. I wanted to update you on the project, which makes up part of the Ross-Jackson Area Improvements and involves upgrading approximately 4 miles of transmission line to ensure electric reliability for area customers. The line travels through Liberty and Coal townships in Jackson County.

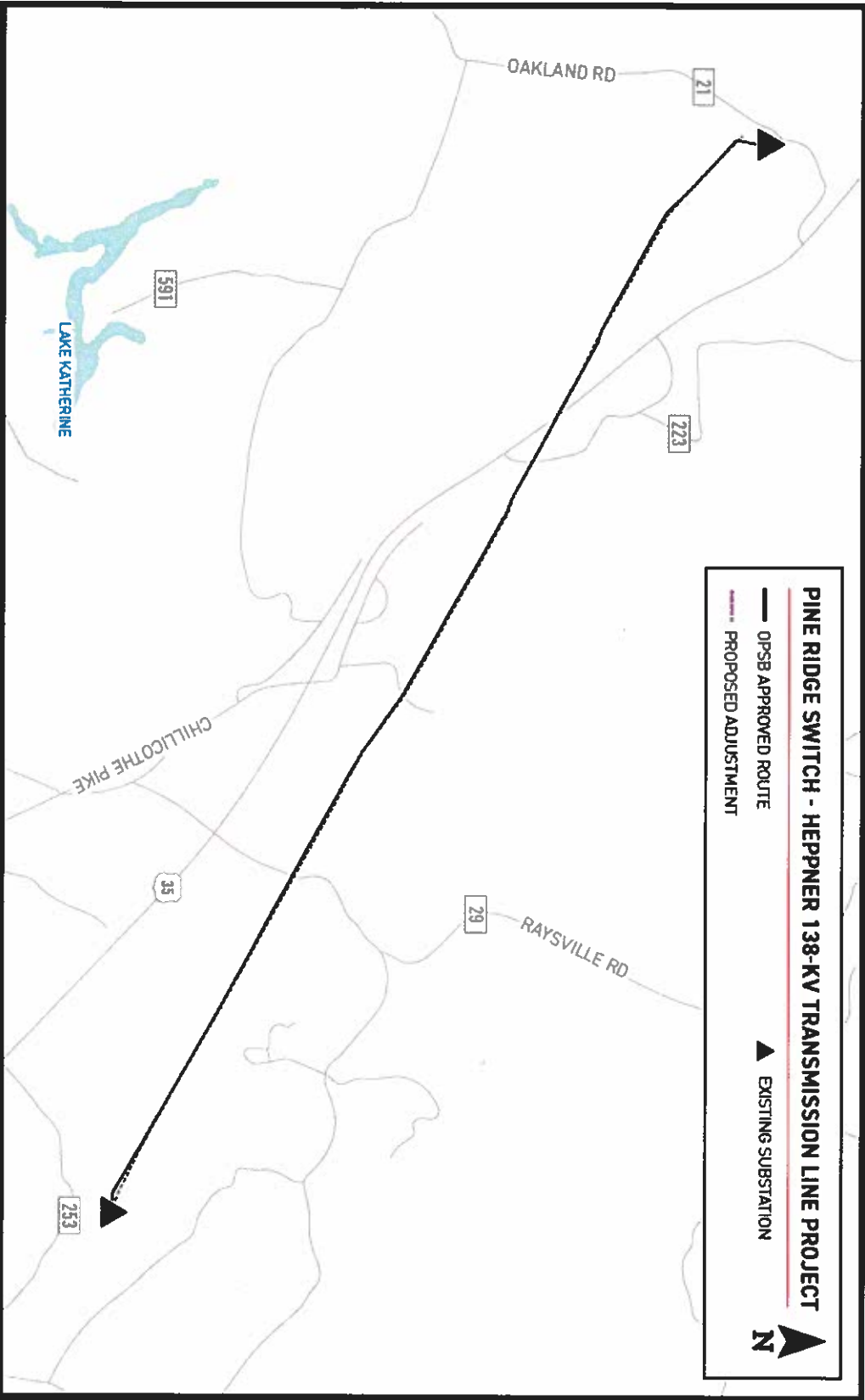
AEP Ohio representatives filed the enclosed amendment with the Ohio Power Siting Board (OPSB) on December 20, 2019 that includes minor changes to an application we previously submitted for the project on March 29, 2018. Since we submitted that application, the following events have taken place leading up to the recently-filed amendment:

- The OPSB certified the application as complete on May 29, 2018 based on the requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1).
- The OPSB approved the application on February 21, 2019 under Case No. 18-0031-EL-BTX.
- The OPSB issued the certificate for the construction, operation and maintenance of the transmission facilities along the preferred power line route.
- AEP Ohio representatives proposed minor adjustments to the approved power line route.
