

**Reason for Reallocation:**

To provide for the mutually equitable and practical reallocation of certain lots between The Toledo Edison Company and North Western Electric Cooperative.

**Metes & Bonds / Detailed Description of Reallocation:**

Being an area of land called North Western Electric territory boundary, situated in the Northeast Quarter of Section 4, Town 10 South, Range 4 West, Northwest Township, Williams County, Ohio. Being more particularly described as follows:

Beginning at the Northeast corner of the Northeast Quarter of Section 4, said point being a pk nail found this survey;

Thence, South 89 degrees 51 minutes 40 seconds West (assumed bearings) along the North line of the Northeast Quarter of said Section 4, a distance of 247.50 feet to a point and the **TRUE POINT OF BEGINNING** of the territory boundary herein described;

Thence, South 00 degrees 00 minutes 00 seconds West a distance of 660.00 feet to a point;

Thence, North 89 degrees 51 minutes 40 seconds East a distance of 247.50 feet to a point;

Thence, South 00 degrees 00 minutes 00 seconds West a distance of 663.40 feet to a point;

Thence, North 89 degrees 53 minutes 50 seconds West a distance of 1011.50 feet to a point;

Thence, North 02 degrees 39 minutes 36 seconds East a distance of 1023.99 feet to a point;

Thence, North 89 degrees 51 minutes 40 seconds East a distance of 235.50 feet to a point;

Thence, North 00 degrees 08 minutes 20 seconds East a distance of 300.00 feet to a point;

Thence North 89 degrees 51 minutes 40 seconds East along the North line of the Northeast Quarter of said Section 4, a distance of 481.71 feet to the **TRUE POINT OF BEGINNING** of the territory boundary herein described.

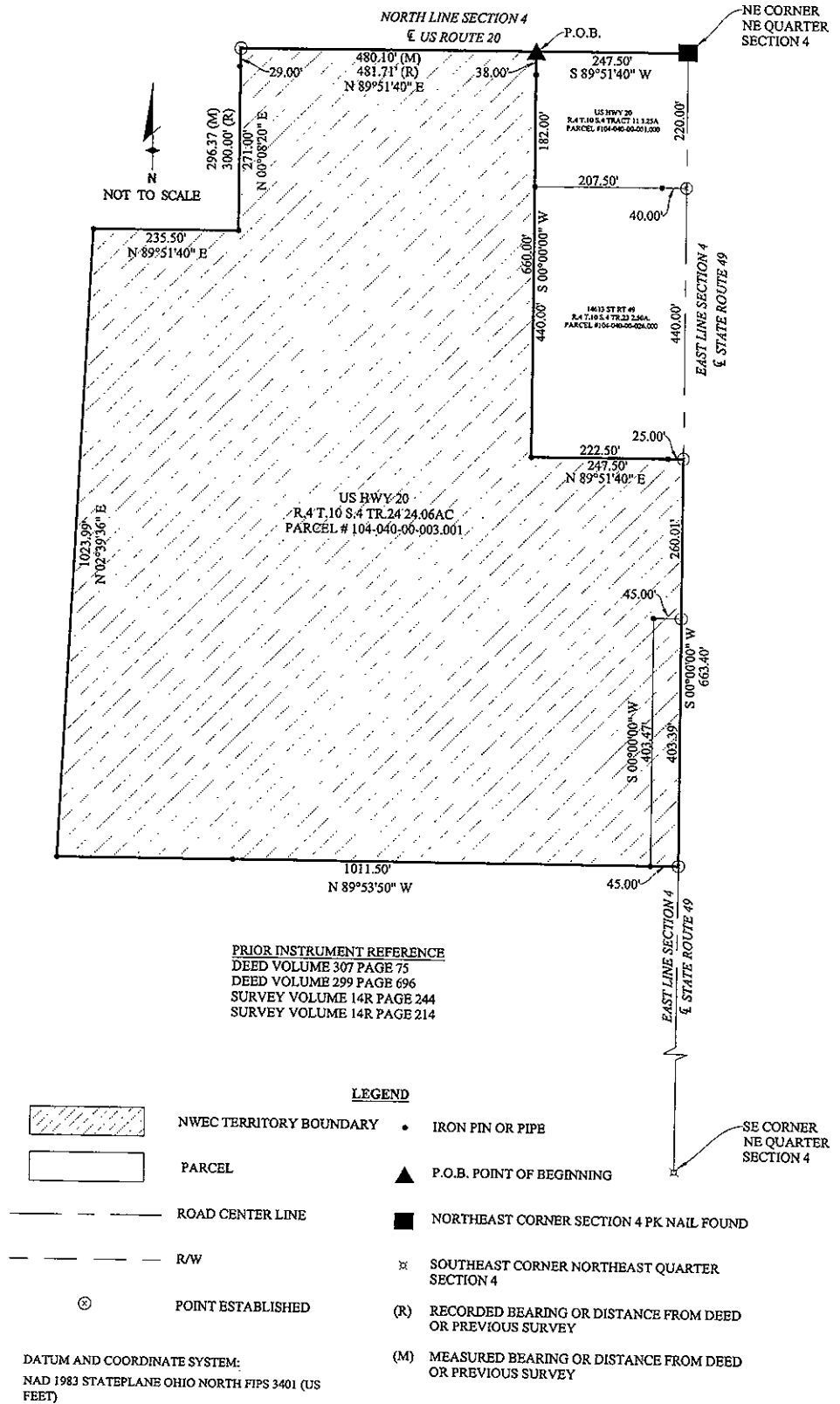

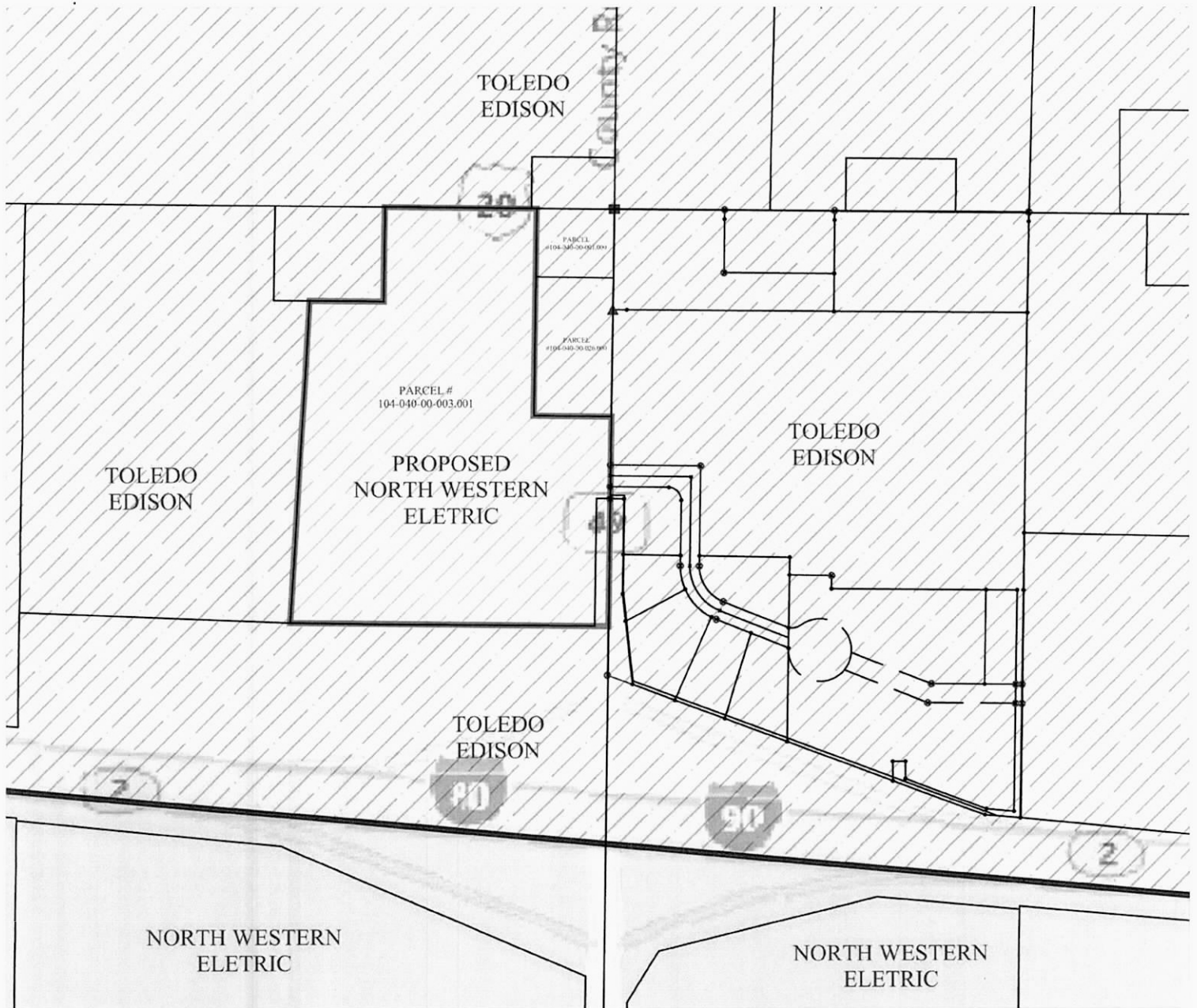
