Dear Ms. Troupe:

On November 11, 2019, the evidentiary record in this case was completed with the filing of the reply briefs by the parties. On December 23, 2019, a letter from Ms. Susan Dempsey, an intervenor in this case who is represented by counsel, filed a letter in the docket. The letter was addressed to the Chairman and was not served on the parties to the case.

In her letter, Ms. Dempsey takes exception to a letter from the President and CEO of the Cleveland Foundation in support of the Icebreaker project that was filed on December 5, 2019. Ms. Dempsey incorrectly asserts that the Cleveland Foundation is a party in this matter indicating that it “seemed inappropriate for an interested party to appeal to the governing agency and other State officials.”

We are submitting this letter to note for the record that neither the Cleveland Foundation nor any of its officers are parties to this case. In that Ms. Dempsey’s letter is an inappropriate filing by an intervening party to this case, we would ask that she refrain from submitting further such filings in the docket.
