APPLICATION AND STATEMENT – PUBLIC VERSION

Pursuant to R.C. 4905.31, Revised Code, Northeast Ohio Gas Natural Gas Corp. (“NEO”) respectfully requests Public Utilities Commission of Ohio (“Commission”) approval of a reasonable arrangement with Bloom Carroll Schools (“Bloom Carroll”) for natural gas delivery service and the building of infrastructure to serve a new school in Carroll, Ohio. In support of the Application, NEO states as follows:

1. NEO is a public utility and a natural gas company subject to the jurisdiction of the Public Utilities Commission of Ohio (the "Commission") by virtue of R.C. 4905.02, 4905.03(E) and 4905.04, and maintains offices at 5640 Lancaster – Newark Road NE, Pleasantville, Ohio, 43148.
2. Bloom Carroll is a school system serving Carroll, Ohio. Bloom Carroll is in the process of building a new elementary school in Carroll, Ohio.
3. Specific elements of the transportation service to Bloom Carroll new school merit deviations from NEO’s approved tariffs or are not contained within their tariffs. Specifically, Bloom Carroll is building a new facility and would like budget certainty for that facility through a fixed monthly distribution charge rather than a volumetric charge as is currently anticipated in NEO’s tariffs.

4. To accommodate Bloom Carroll's reasonable request, NEO and Bloom Carroll have agreed to a reasonable rate arrangement and have agreed to rates and other terms and conditions of service that differ from NEO's tariff (the "Agreement"). A copy of the redacted Agreement between NEO and Bloom Carroll is attached to this Application as Attachment A. The redactions represent confidential information, and by separate motion, NEO is requesting protective treatment of said confidential information.

5. NEO submits that the Agreement constitutes a reasonable arrangement under R.C. 4905.31 and should be approved.

6. Approval of the Agreement will allow NEO to provide reliable natural gas transportation service at an acceptable cost to Bloom Carroll's new school.

7. The provision of natural gas transportation service shall not impair or reduce the quality of transportation service to other NEO customers.

8. NEO submits that no hearing is required on this Application and that the public interest is served by the Commission expeditiously approving the same.

WHEREFORE, NEO respectfully requests the Commission approve the Agreement as a reasonable arrangement under R.C. 4905.31.
