#### **MEMORANDUM IN SUPPORT**

Pursuant to O.A.C. 4901:2-7-12, the Staff of the Public Utilities Commission of Ohio ("Staff") served Michael Maag ("Respondent") with a Notice of Preliminary Determination regarding the Respondent's alleged violation of CFR 393.48A, 393.9T, 393.43, 390.21B, and 392.9BA-NOR 4. In response to a request for additional information sent from Staff to the Respondent, the Respondent explained that he is not a commercial hauler pursuant to Federal Motor Safety Regulations. After a review of the facts and further investigation, Staff agrees with the Respondent.
