The October 5, 2017, Opinion, Order, and Certificate ("Certificate") approving Guernsey Power Station, LLC ("GPS") Certificate of Environmental Compatibility and Public Need to Construct the Guernsey Power Station approved the Stipulation which set forth a set of conditions as part of the Certificate.

Within this set of conditions, **Condition No. 2** requires that GPS provide the Ohio Power Siting Board ("OPSB") Staff a preconstruction conference agenda and to conduct a preconstruction conference prior to the commencement of construction activities. As required by the condition and O.A.C. 4906-3-14(B), the meeting must include representatives of the prime contractor and subcontractors.

The agenda for the preconstruction conference for the underground utilities and foundation phase of construction was provided to OPSB Staff on January 8, 2020. A copy of the agenda is attached to this notice and shows the roster of attendees, including contractor representatives.

The preconstruction conference for the underground utilities and foundation phase of construction was held on January 27, 2020.
