#### JOINT MOTION TO DISMISS

The joint dismissal is subject to the elimination of the deposits and associated late fees on both of Republic's electric service accounts with AEP Ohio and the appropriate accounting of such. The Parties also expressly reserve their rights to challenge or initiate any future application or assessment of security deposits and/or late fees to Republic's electric service accounts. The reasons for the motion are set forth in the attached memorandum in support.
