

# **Notice of First Amendment to** Major Utility Facility FACILITY DESCRIPTION

The Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need on October 5, 2017 in Case No. 16-2443-EL-BGN, and as amended in Case No. 18-0090-EL-BGA, authorizing Guernsey Power Station LLC to construct, own and operate an 1,650 megawatt (MW) gas fired, combined cycle power station, Guernsey Power Station, to be located in Valley Township, Guernsey County off of Puritan Street. Seneca Lane, Interstate 77. Clay Pike Road, and a private rail line generally border the project area.

### LOCATION AND GENERAL LAYOUT

The general location and planned project layout of Guernsey Power Station is shown on the map below:



#### SECOND AMENDMENT NOW PENDING

Guernsey Power Station, LLC has a Second Amendment Application pending before the Ohio Power Siting Board to add an additional 225 MW of capacity for a total of 1,875 MW which was contemplated at the time of the filing of the First Amendment Application.
