SUPPLEMENT TO JOINT STIPULATION AND RECOMMENDATION

Applicant Nestlewood Solar I LLC (“Nestlewood” or “Applicant”), the Ohio Farm Bureau Federation, and the Staff of the Ohio Power Siting Board (“Staff”), hereby agree to supplement Section III of the June 12, 2019 Joint Stipulation and Recommendation (“Stipulation”) filed in this proceeding by inserting a new Condition 31 as follows:

If one acre or more of ground is disturbed, the Applicant shall obtain from Ohio EPA a “General Permit Authorization for Storm Water Discharges Construction Associated with Construction Activities” (also known as a Construction General Permit). Following the completion of final project engineering design, the Applicant shall perform pre- and post-construction stormwater calculations to determine if post-construction best management practices are required, based on requirements contained in Ohio EPA’s Construction General Permit. The calculations along with a copy of any stormwater submittals made to the Ohio EPA shall be submitted to the Clermont County Building Inspection Department and Brown County Soil & Water Conservation District. The Applicant will also provide confirmation that it incorporated guidance from the Ohio EPA’s document “Guidance on Post-Construction Storm Water Controls for Solar Panel Arrays” dated October 2019 to the Clermont County Building Inspection Department and Brown County Soil & Water Conservation District. If post construction storm water best management practices are required, the Applicant will submit construction drawings detailing any stormwater control measures to the Clermont County Building Inspection Department and the Brown County Soil & Water Conservation District, as applicable, no less than seven days prior to the applicable construction activities.

The Parties expressly agree that the provisions of the Joint Stipulation and Recommendation that are not amended remain in full force and effect.
