Great American Power, LLC ("GAP") was licensed to supply electricity in Pennsylvania on January 13, 2011, docket number: A-2010-2205475. On October 16, 2011, GAP was licensed to supply electricity in Maryland, docket number: IR-2440. On December 15, 2014, Great American Power Holdings, LLC (GAP's parent company), purchased Perigee Energy, LLC ("Perigee"). Perigee is licensed in Ohio, New York, Massachusetts, Connecticut and Delaware. Since December 2014, both companies have been operated by the same management team and employees, just under separate names. On May 8, 2016, GAP was licensed to supply electricity in Ohio, Certificate Number: 16-1073E (1). On February 2, 2017, Perigee Energy, LLC was sold in the second quarter of 2017. On February 8, 2018, GAP was licensed to supply natural gas in Ohio, Certificate Number: 18-641G (1). On February 28, 2018 GAP was licensed to supply electricity in Illinois, Certificate Number 18-0170, and on March 21, 2018 GAP was also licensed to supply natural gas in Illinois, Certificate Number 18-0341.

BY THE COMMISSION:

On October 19, 2010, Great American Power LLC (GAP) filed an application seeking to become a licensed electric generation supplier (EGS) in the electric distribution company (EDC) service territories of PECO Energy Company, PPL Electric Utilities and Metropolitan Edison Company within the Commonwealth of Pennsylvania. The application was filed pursuant to the Commission's regulations at 52 Pa. Code §§ 54.31-54.43, which became effective on August 8, 1998, and which were established under Section 2809 of the Public Utility Code, 66 Pa. C.S. § 2809.

§ 2809 provides, in pertinent part, that:

License Requirement.—No person or corporation, including municipal corporations which choose to provide service outside their municipal limits except to the extent provided prior to the effective date of this chapter, brokers and marketers, aggregators and other entities, shall engage in the business of an electric generation

electricity grid; therefore, the rules relating to residential service termination are not applicable to electric generation suppliers. An electric generation supplier may seek to terminate its generation service through an appropriate written notice to the customer and the distribution company. The residential customer can then attempt to repair their relationship with the supplier, seek a new supplier, or default to utility service at capped rates in accordance with the utility's obligations under Section 2807(e), 66 Pa. C.S. § 2807(e). The customer would only be disconnected from the electricity grid pursuant to appropriate regulations if the customer failed to meet its obligations to the utility or the electric generation supplier that has been designated by the Commission as the provider of last resort.

Additionally, we specifically note that the licensee must comply with, and ensure that its employees, agents, representatives, and independent contractors and subcontractors comply with the standards of conduct and disclosure for licensees set out in Commission regulations at 52 Pa. Code § 54.43 that were enacted to protect consumers of this Commonwealth. These standards include, inter alia, the provision of timely and accurate information about the services offered by the licensee, the practice of nondiscrimination in service in regard to race, color, religion, national origin, marital status, etc., the safeguarding of a consumer's personal information, and compliance with applicable state and federal consumer protection laws. Also, we take this opportunity to remind the licensee of its agreement to abide by, and to ensure that its employees, representatives, agents, and independent contractors and subcontractors abide by all applicable federal and state laws, and Commission regulations, procedures and orders, including Emergency Orders, which may be issued verbally or in writing during any emergency situations that may unexpectedly develop from time to time in the course of doing business in Pennsylvania. See, for example, 52 Pa. Code § 54.43(f) ("A licensee is responsible for any fraudulent deceptive or other unlawful marketing or billing acts performed by the licensee, its employees, agents or representatives.").

GAP proposes to utilize a call center in Pennsylvania to market to residential customers. GAP will utilize the services and personnel of TOD to operate the call center. GAP states that it is not the intent to utilize the call center to offer telemarketing services to other Pennsylvania licensed electric generation suppliers and that TOD understands that it must first secure an electric generation supplier license as a broker/marketer in order for TOD or its personnel to engage in telemarketing services for other EGSs.

GAP has provided a \$250,000 letter of credit as required by the license application.

As of January 3, 2011, no protests have been filed.

We find that the applicant:

- Is fit, willing and able to properly perform the service proposed in conformance with applicable provisions of the Public Utility Code and lawful Commission Orders and regulations, specifically including 52 Pa. Code Chapter 56 (relating to Standards and Billing Practices for Residential Utility Service).
- 2. Has agreed to lawfully abide by all Commission regulations, procedures and Orders, including Emergency Orders, which may be issued verbally or in writing during any emergency situations that may unexpectedly develop from time to time in the course of doing business in Pennsylvania.

We further find that the proposed service, to the extent authorized by the license, will be consistent with the public interest and the policy declared in the Electricity Generation Customer Choice and Competition Act.

5. That this proceeding at Docket No. A-2010-2205475 be closed.

ORDER

By the Commission:

I. PRELIMINARY MATTERS

On January 24, 2018, Great American Power, LLC ("Applicant") filed a verified Application with the Illinois Commerce Commission ("Commission") requesting a certificate of service authority to operate as an alternative retail electric supplier ("ARES") in Illinois pursuant to Section 16-115 of the Public Utilities Act ("Act"), 220 ILCS 5/1-101 et seq., and 83 Ill. Adm. Code 451 ("Part 451") and a Motion for Confidential Treatment. Applicant submitted its certificate of publication showing that on January 28, 2018, notice of the Application was published in the Official State Newspaper. The Commission Staff requested further information regarding certain matters in the Application. On February 14, 2018, Applicant filed an Amended Application with the additional information and a revised Motion for Confidential Treatment.

II. BACKGROUND AND AUTHORITY SOUGHT BY APPLICANT

Applicant is a Pennsylvania limited liability corporation authorized to transact business in Illinois. Applicant requests a certificate of authority to operate as an ARES. Applicant seeks a certificate to serve all eligible retail customers in the Commonwealth Edison Company service territory. Applicant is currently licensed as an ARES in Pennsylvania, Maryland and Ohio. Applicant states it is not affiliated with any utility, and does not own transmission or generation facilities. Applicant does not seek authority to provide single-billing services, under subpart F of Part 451.

III. REQUIREMENTS UNDER SECTION 16-115(D) OF THE ACT

A. General

Applicant has certified that it will comply with all applicable regulations; that it will provide service only to retail customers eligible to take such services; that it will comply with informational and reporting requirements established by Commission rule; and that it will comply with all other applicable Federal, State, regional and industry laws, regulations, terms, and conditions required to the extent they have application to the

services being offered by an ARES. Additionally, Applicant has agreed to submit good faith schedules of transmission and energy in accordance with applicable tariffs. Applicant certifies that it will provide for review by Commission Staff on a confidential basis data related to contracts for the purchase and sale of electric power and energy. Applicant has agreed to adopt and follow rules relating to customer authorizations, billing records, and retail electric services and agrees to retain requests for delivery services transmitted to utilities for a period of not less than two calendar years after the calendar year in which they are created. Applicant has agreed to adopt and follow rules and procedures to preserve the confidentiality of its customers' data.

Applicant asserts it has not been denied an electric supplier license, nor has it had an electric supplier license suspended or revoked by any state.

Applicant certifies it will procure renewable energy resources as required by Section 16-115D and subsection (d) of Section 16-115 of the Act. Applicant also certifies that it will source electricity from clean coal facilities as required by Section 16-116(d)(5) of the Act. Applicant states that it will not use electric generation, transmission or distribution facilities that it owns, controls or operates in serving customers.

Pursuant to the requirements of Subpart D of Part 451, Applicant certifies that any marketing materials that make statements concerning prices, terms and conditions of service shall contain information that adequately discloses the prices, terms and conditions of the products or services that it is offering or selling to the customer. Applicant also certifies that before any customer is switched from another supplier, it will give the customer written information that adequately discloses, in plain language, the prices, terms and conditions of the products and services being offered and sold to the customer. Applicant further certifies that it will provide documentation to the Commission and to customers that substantiates any claims made regarding the technologies and fuel types used to generate the electricity offered or sold to customers. Applicant commits to provide to its customers itemized billing statements that describe the products and services provided to the customer and their prices; and an additional statement, at least annually, that adequately discloses the average monthly prices, and the terms and conditions, of the products and services sold to the customer.

Applicant certifies that it will include materials comprising the consumer education program pursuant to Section 16-117 of the Act with all initial mailings to potential small commercial retail customers and before executing any agreements or contracts with such customers. Applicant certifies that it will also provide consumer education program materials pursuant to Section 16-117 of the Act, at no charge to small commercial retail customers, upon request. Applicant certifies that it will provide to small commercial retail customers on a semi-annual basis information on how to obtain a list of alternative retail electric suppliers that have been found in the last three years by the Commission to have failed to provide service in accordance with the terms of their contracts pursuant to Section 16-117(g) (4) (C) of the Act.

Pursuant to the requirements of Section 451.50 of Part 451, Applicant provided a License or Permit Bond issued by a qualifying surety authorized to transact business in Illinois.

B. Financial, Technical, and Managerial Requirements

Applicant asserts that it meets the financial qualifications criteria set forth in Part 451.320(a). Included in Attachment 19 to the Application is information intended to demonstrate that Applicant meets the criteria.

Applicant represents that it meets the technical and managerial qualifications set forth in Section 16-115(d)(1) of the Act and Sections 451.330 and 451.340 of Part 451. The Amended Application and Attachment 22 contains information regarding the technical and managerial qualifications of Applicant's staff and its agents or contractors. Attachment 23 to the Amended Application includes a corporate organizational chart. Applicant provided a telephone number and facsimile number through which it states a staff member can be reached at all times.

Applicant states it is not relying on one or more agents or contractors to meet the technical and managerial requirements of Part 451.

IV. CUSTOMER COMPLAINTS

Applicant discloses that it is not the subject of any lawsuits that were filed in a court of law. Applicant further states that it has no other formal complaints filed with a regulatory agency alleging fraud, deception or unfair marketing practices, or other similar allegations.

V. REQUEST FOR CONFIDENTIAL TREATMENT

Applicant seeks confidential treatment of certain redacted information filed in attachments with the Amended Application. Applicant indicates that these documents contain highly proprietary and confidential commercial and financial information, the disclosure of which to competitors would likely be detrimental to Petitioner given the highly competitive nature of the electric industry. The Commission has reviewed the request for confidential treatment and finds that it is appropriate to grant a two-year period of confidential treatment for the redacted information in the attachments to the Application. The Commission concurs with Applicant that disclosure of the redacted information and use by a competitor is apt to cause the Applicant competitive harm. Applicant's confidential information in the Commission's possession should, therefore, be accessible only by the Commission and Commission Staff, unless such information is or becomes publicly available from another source.

VI. COMMISSION CONCLUSION AND CERTIFICATE OF SERVICE AUTHORITY

The Commission has reviewed the Application and all attachments provided by Applicant regarding the technical, financial, and managerial requirements and all other requirements of the Act and Part 451 and finds that the Applicant sufficiently demonstrates compliance with the requirements.

The Commission concludes, therefore, that Applicant's request for a certificate of service authority to operate as an ARES in Illinois should be granted and should include the following authority:

CERTIFICATE OF SERVICE AUTHORITY

IT IS CERTIFIED that Great American Power, LLC is granted service authority to operate as an Alternative Retail Electric Supplier as follows:

SERVICES TO BE PROVIDED: The sale of electricity and power.

CUSTOMERS TO BE SERVED: All eligible retail customers.

GEOGRAPHIC REGION(S) SERVED: For the sale of electricity and power in the service area of Commonwealth Edison Company.

VII. FINDINGS AND ORDERING PARAGRAPHS

The Commission, having reviewed the entire record, is of the opinion and finds that:

- (1) Applicant, Great American Power, LLC, a corporation organized under the laws of New York, seeks a certificate of service authority to operate as an alternative retail electric supplier under Section 16-115 of the Act;
- (2) the Commission has jurisdiction over the parties hereto and the subject matter hereof;
- (3) the recitals of fact and conclusions reached in the prefatory portion of this Order are supported by the record and are hereby adopted as findings of fact, as required by Section 16-115(d) of the Act;
- (4) Applicant has demonstrated that it possesses sufficient financial, managerial and technical resources and abilities to provide power and energy to all eligible retail customers throughout the service area of Commonwealth Edison Company;
- (5) Applicant has complied with Section 16-115(d)(1) through (5) and (8) of the Act and 83 Ill. Adm. Code 451;
- (6) Section 7(1)(g) of the Illinois Freedom of Information Act (5/ILCS 140/7) exempts from public disclosure:

Trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that disclosure of the trade secrets or commercial or financial information would cause competitive harm to the person or business, and only insofar as the claim directly applies to the records requested;

(7) Applicant's redacted information falls within the exemption stated in Finding (6);

- (8) the documents and portions of documents for which Applicant seeks proprietary treatment should be exempt from public disclosure under Section 7(1)(g) of the Freedom of Information Act and Section 5-109 of the Act for a period of two years from the date this Order is entered; and
- (9) Great American Power, LLC should be granted a certificate of service authority to operate as an alternative retail electric supplier as specified in Section VI of this Order.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that Great American Power, LLC is hereby granted a Certificate of Service Authority as set forth in Section VI of this Order.

IT IS FURTHER ORDERED that Great American Power, LLC shall comply with all applicable Commission rules and orders now and as hereafter amended.

IT IS FURTHER ORDERED that, subject to the provisions of Section 10-113 of the Public Utilities Act and 83 III. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.

Great American Power, LLC, a Pennsylvania Limited Liability Company ("GAP"), is a Competitive Retail Electric Service Provider with plans to selectively expand into deregulated states and utility territories. GAP has been successfully operating as a retail energy supplier in Maryland and Pennsylvania since 2011. GAP's executive team is an elite group of energy professionals with an impressive variety of industry experience (See Exhibits D-2 "Operational Expertise" and D-3 "Key Technical Personnel"). GAP's planned process for contracting with customers, providing contracted services, providing billing statements, and responding to customer inquiries and complaints will be in accordance with Commission rules adopted pursuant to Section 4929.20 of the Revised Code and contained in Chapter 4901:1-29 of the Ohio Administrative Code.

Exhibit B-3 "Summary of Experience

Great American Power, LLC's ("GAP") executive team has a substantial business background in the energy industry. (See Exhibits D-2 "Operational Expertise" and D-3 "Key Technical Personnel"). GAP intends to strategically expand into deregulated markets throughout the United States offering both electricity and natural gas to residential, commercial and industrial customers. The executive managers will oversee all aspects of operations, finance, sales, and customer service for the company as they expand into new territories and utilities.

Exhibit B-4 "Disclosure of Liabilities and Investigations"

Great American Power, LLC ("GAP"), was involved in a formal complaint in Pennsylvania that was initiated on June 5, 2012. This complaint involved a telemarketing campaign in which the individual stated they did not wish to receive further calls, but were contacted again anyway. The customer was never enrolled with GAP, and we no longer use the telemarketing vendor. We have also implemented an improved Quality Assurance program that we use when marketing with a third party vendor as well as with our internal customer service representatives, including regular monitoring, both live and past calls, vigorous TPV standards, and tracking of call dispositions with our internal Customer Service to catch any problems right away. The formal complaint was closed on September 26, 2013, and the final fines were paid on October 9, 2013.

The Pennsylvania PUC began an informal investigation following the closing of the formal complaint, which concluded in a settlement agreement dated March 28, 2016. The settlement concerned customers affected by the same telemarketing campaign.

The formal complaint and the resulting informal investigation will not negatively impact our ability to operate in the retail market because both have been since concluded, and we no longer engage the offending telemarketing company. Further, the resulting processes that we have implemented as a result only made our Quality Assurance Program stronger and better equipped to avoid such situations in the future.



The GAP staff is responsible for natural gas scheduling and settlement, pricing, risk management, billing, tax filings, regulatory filings, and customer service. (See Exhibit D-2 "Operational Expertise" and Exhibit D-3 "Key Technical Personnel"). Our team is dedicated to compliance with the Public Utilities Commission of Ohio's rules and regulations as well as strict adherence to market and utility protocols.

GAP's wholesale supply needs (energy, capacity and renewable energy) will be provided by a third-party as indicated in the Loan and Energy Services Agreement. GAP additionally has engaged the third-party provider in a Gas Services Agreement. (See Exhibit VIII "Contractual Arrangements for Capability Standards"). Our EDI transactions will be conducted by Latitude Technologies, an experienced and highly rated EDI company that will ensure quality data communications between GAP and the utilities.

GAP intends to expand into deregulated markets in a strategic manner. We intend to recruit additional experienced industry talent to streamline middle and back office functions to ensure exceptional service for both business partners and our customers.
