## MEMORANDUM IN SUPPORT

### **I. Renewal of CRES Certification**

On August 2, 2017, Applied Energy Partners, LLC (“Applied Energy”) filed its initial Application for Certification (“CRES Application”) as a competitive retail electric supplier (“CRES”) with the Public Utilities Commission of Ohio (“PUCO” or “Commission”). This Commission approved Applied Energy’s CRES Application. As a result, Applied Energy was issued its certificate (“Certificate 18-1294E(1)”) on February 26, 2018. Certificate 18-1294E(1) is effective through February 24, 2020.

Under Ohio Admin. Code (“O.A.C.”) §4901:1-24-09(A), Applied Energy is required to file its application for certification renewal with the Commission no later than thirty (30) days before Certificate 18-1294E(1)’s expiration date. Due to an administrative oversight, Applied Energy failed to file its renewal application by January 25, 2020. Therefore, in accordance with O.A.C. §4901:1-24-09(B), Applied Energy requests an extension of its current certificate until at least 30 days from the date of this motion. Applied Energy’s renewal application is being filed concurrently with this Motion as is required under O.A.C. §4901:1-24-09(B).

### **II. Renewal of CRNG Certification**

Applied Energy also filed its initial Application for Certification (“CRNG Application”) as a competitive retail natural gas aggregator/broker (“CRNG”) with the Commission on January 24, 2018. This Commission approved Applied Energy’s CRNG Application. As a result, Applied Energy was issued its certificate (“Certificate 18-643G(1)”) on February 28, 2018. Certificate 18-643G(1) is effective through February 24, 2020.

Under Ohio Admin. Code (“O.A.C.”) §4901:1-27-09(A), Applied Energy is required to file its application for certification renewal with the Commission no later than thirty (30) days

before Certificate 18-643G(1)'s expiration date. Due to an administrative oversight, Applied Energy failed to file its renewal application by January 25, 2020. Therefore, in accordance with O.A.C. §4901:1-27-09(B), Applied Energy requests an extension of its current certificate until at least 30 days from the date of this motion. Applied Energy's renewal application is being filed concurrently with this Motion as is required under O.A.C. §4901:1-24-09(B).
