The Company respectfully requests that the Commission issue an updated Certificate to reflect the Company's name as "Intrado Communications, LLC." The Company is authorized to provide resold and facilities-based local exchange and long distance telecommunications services in Ohio pursuant to authority granted in Certificate No. 90-9197; Case No. 08-1018-TP-ACN.

A copy of the Company's name change filing with the Ohio Secretary of State is attached hereto as <u>Exhibit A</u>. The Description of Transaction is attached hereto as <u>Exhibit C</u>.
