MEMORANDUM IN SUPPORT

On January 16, 2020, in Case No. 20-48-GA-BLN, Duke Energy Ohio filed an application, in the form of a letter of notification, for approval by the Board of a project intended to improve the Company's natural gas pipeline system, through the construction of a line near and along Round Bottom Road, in Newtown, Ohio. As of the date of filing, the Company had not yet agreed upon easements with all of the affected landowners, although it believed that it would be able to do so eventually.

The Board approved the application for the Round Bottom Road project, effective February 14, 2020. Following that date, Duke Energy Ohio determined that it would not be able to reach agreement on easement terms with one landowner along the southern portion of the route. As a result, the Company has developed a second approach to completion of this improvement project, which approach requires crossing the property of two additional landowners. Those landowners have provided the necessary easements.

The application in the present case seeks Board approval of the modified section of the route, affecting only those two additional landowners. Because of the minimal impact of this revised route and because both newly affected landowners have already executed easements for the project, Duke Energy Ohio seeks a waiver of the requirements to publish notice of the project in the newspaper and to notify every affected landowner and tenant along the entirety of the route. The Company does intend to notify the owners (and tenants, if any) of the newly affected properties, as well as governmental officials and the local library.

Finally, Duke Energy Ohio respectfully requests expedited treatment of this motion as the clearing of trees on the new portion of the route must be accomplished prior to the end of March, when bat roosting season begins. As there were no intervenors in Case No. 20-0048-GA-BLN,

and there is no dispute with the newly affected landowners, no intervenors are anticipated in this proceeding.
