Now comes Ultimate Energy Advisors, LLC, by and through its counsel, and hereby requests that the Public Utilities Commission of Ohio extend Certificate Number 14-342G (2) [the “Certificate”], pursuant to which Ultimate Energy Advisors, LLC [“Applicant”] is certified as a Competitive Retail Electric Service Provider.

Upon information and belief, the Certificate is due to expire on March 14, 2020. Ultimate Energy Advisors, LLC filed a renewal application on February 20, 2020, which was less than thirty days prior to expiration of the Certificate. Applicant also has a Certificate to operate as a competitive retail electrical service provider, which expires on March 22, 2020. The differing expiration dates for the existing certificates caused Applicant to miss calculate the deadline for filing a renewal application. This Motion is made timely and in accordance with the provisions of Ohio Administrative Code §4901:1-27-09 (B), which states in pertinent part as follows:

“Any renewal application filed fewer than thirty calendar days prior to the expiration date indicated on the certificate, but no later than the expiration date on the

certificate, shall be filed with a motion requesting an extension of the certificate.”

Accordingly, Applicant hereby requests that the Certificate be extended during the pendency of the renewal application for a period of sixty (60) days, until May 13, 2020. Ohio Administrative Code §4901:1-27-09 (B) provides that a motion to extend will be deemed to be automatically approved if it is filed in conformance with rule 4901:1-27-07 of the Administrative Code, unless, within three business days of filing, the commission or an attorney examiner appointed by the commission rules otherwise. Applicant requests that this Motion be granted so that its customers do not experience any interruption in service and are not otherwise adversely impacted by its inadvertent delay in filing its application for renewal.
