Notice of Public Information Meeting for Proposed Major Utility Facility

The Ohio State University ("Ohio State") has previously notified the public of a proposed combined heat and power ("CHP") major unit facility to be located on the campus of The Ohio State University in Franklin County, Ohio. Ohio State has filed with the Ohio Power Siting Board (Board) an application for a Certificate of Environmental Compatibility and Public Need to construct the CHP facility in Case No. 19-1641-EL-BGN, which is now pending before the Board.

In light of the extraordinary events relating to COVID-19, the Board has ordered that the procedural schedule in this proceeding be suspended. That includes, among other things, the local public hearing and adjudicatory hearing. Ohio State will provide additional public notice when the local public hearing and adjudicatory hearing have been rescheduled. Interested parties are also advised to follow all case activity on the Board's docketing website with regard to future changes to the case schedule.

While the local public hearing has been postponed, the public is still encouraged to submit informal written comments to the Board. In order to be filed in the public comments section of the case record, submissions must include the case number. These comments inform the Board, as well as Staff during its investigation, but do not carry the same weight as the sworn testimony presented at the local public hearing.
