**VISTRA ENERGY CORP.'S MEMORANDUM IN SUPPORT OF INTERSTATE GAS
SUPPLY, INC.'S REQUEST TO ESTABLISH PROCEDURAL SCHEDULE**

Vistra Energy Corp. ("Vistra") submits this Memorandum in Support of Interstate Gas Supply, Inc.'s ("IGS's") Request to Establish Procedural Schedule filed on March 25, 2020. Vistra agrees that establishing a procedural schedule is necessary to ensure Suvon, LLC d/b/a FirstEnergy Advisors' application for certification as an aggregator and power broker ("Application") complies with Ohio law. Vistra and other parties raised serious concerns regarding the Application's compliance with Ohio Admin. Code 4901:1-24-10(C) and numerous retail competition and consumer protection laws. A reasonable procedural schedule will allow the Commission and parties to fully evaluate the Application's compliance with these laws. Vistra supports the procedural schedule proposed by IGS, but is also amenable to revisions the Commission may deem necessary or appropriate to facilitate timely resolution and avoid undue delay in this case.
