On October 31, 2016, the Ohio Rail Development Commission (ORDC) authorized construction for Norfolk Southern to upgrade active warning devices at the following location:

On December 21, 2016, the Commission issued a Finding and Order approving the project and ordering completion by December 21, 2017. The case was placed into abeyance, on December 20, 2017, until CSX completed work on the adjacent track (under Case 17-2292-RR-FED) in March 2019. Norfolk Southern then completed the project work and put the devices in service.
