Pursuant to Ohio Administrative Code 4901:1-27-11, Titan Gas, LLC d/b/a Titan Gas and Power hereby provides notice of a material change in information in its Renewal Certification Application Competitive Retail Natural Gas Suppliers filed November 22, 2019 ("Renewal Application").


