#### MEMORANDUM IN SUPPORT

#### I. INTRODUCTION

Duke Energy Ohio respectfully requests leave to file its corrected reply comments on its Application to adjust Rider PF one day out-of-time. Pursuant to the Entry issued on March 11, 2020<sup>1</sup>, Duke Energy Ohio's reply comments on its Application to adjust Rider PF were due to be filed on May 15, 2020. The Company filed its reply comments timely on May 15, 2020 (as reflected in the docket), but inadvertently omitted a one-page attachment. When the Company realized the omission, it corrected its filing by adding the one-page attachment. No other changes were made.

The Company attempted to re-file its corrected reply comments immediately. Due to COVID-19 and remote working requirements, a remote server connection error occurred that delayed the processing of the corrected filing by a few minutes, causing the corrected reply comments to not be uploaded to the Commission's electronic docketing system until 5:33 p.m. on May 15, 2020. Because the filing of the corrected reply comments was completed three minutes after the 5:30 p.m. deadline, Duke Energy Ohio's corrected reply comments were deemed to be filed one day out-of-time. Given the brief delay in the second corrected filing due to the remote server connection error, no parties to this proceeding will be prejudiced as a result of the late filing. Indeed, Duke Energy Ohio served its corrected reply comments on all the parties on the due date of May 15, 2020. As such, there will not be any undue delay to this proceeding and allowing Duke Energy Ohio to file its corrected reply comments one day out-of-time will not result in any harm or burden to the parties to this proceeding. Motions for out-of-time will not result in any harm or burden to the parties to this proceeding. Motions for out-of-
