Re: PUCO Case No. 17-2415-RR-FED In the Matter of a Request for Upgrades to the Active Warning Devices at CSX Transportation Inc. Grade Crossing, DOT# 513-680R, on SR 613/Main Street in Hancock County, Ohio.

On October 30, 2017, the Ohio Rail Development Commission (ORDC) authorized construction for CSX Transportation to upgrade active warning devices at the following location:

On January 3, 2018, the Commission issued a Finding and Order approving the project and ordering completion by October 3, 2018. CSX experienced construction delays due to PTC crew limitations. The Commission granted extensions until March 20, 2019.
