JOINT MOTION FOR THIRD EXTENSION OF TIME

By Entry dated December 18, 2019, the Commission directed Staff to prepare a report with respect to a gas incident that occurred in November 2019 in Pepper Pike, Ohio. The Entry also directed Dominion Energy Ohio (DEO) to “respond in writing to the staff investigate report within 30 days of its filing.”

Staff filed its report on February 28, 2020. The 30-day period to respond ended on March 30, 2020. On March 17, Dominion and Staff jointly requested an extension to respond to the Staff Report by April 29, 2020. The Commission granted that extension on March 24. On April 24, 2020, Dominion and Staff jointly requested a second extension to respond to the Staff Report by May 29, 2020. The Commission granted that extension on April 28.

DEO and Staff now request an additional extension of two weeks of the deadline to respond to the Staff Report. DEO and Staff have discussed the findings and recommendations and continue to work toward resolving them. Both parties, however, have also had to divert resources to implementing the Governor’s Executive Orders regarding the COVID-19 pandemic. An additional two weeks will enable DEO and Staff to continue their dialogue about the Staff Report while also addressing an ever-evolving public health crisis.

Accordingly, DEO and Staff respectfully request an additional extension of two weeks, or until June 12, 2020, for DEO to respond to the Staff Report.
