This notice is provided to inform the Commission about changes to the information provided in CenterPoint Energy Services, Inc.'s ("CenterPoint") certificate as a Competitive Retail Natural Gas Marketer under Certificate Number 16-530G(2) issued pursuant to Case Number 16-1370-GA-CRS. On June 1, 2020, CenterPoint was indirectly acquired by an affiliate of Energy Capital Partners, a private equity and credit investment firm with over \$19 billion in capital commitments focused on investing in the power generation, midstream gas, electric transmission and energy and environmental services sector of North America's energy infrastructure. As a result of such acquisition, CenterPoint is no longer affiliated with CenterPoint Energy, Inc. As such, CenterPoint has converted to a limited liability company and changed its name to Symmetry Energy Solutions, LLC ("Symmetry"). A copy of the conversion and name change issued by the Delaware Secretary of State is attached hereto. Symmetry will continue to operate as a Competitive Retail Natural Gas Marketer to customers in Ohio pursuant to the certificate issued in the above-referenced case.
