#### Disney, SeaWorld plan for Florida parks to reopen

SeaWorld and Walt Disney World will reopen in Orlando, Florida, in June and July, after months of being closed because of the coronavirus pandemic, according to plans that a city task force approved Wednesday.

The plan calls for SeaWorld to open to the public June 11.

Disney plans a tiered reopening, with Magic Kingdom and Animal Kingdom opening July 11, followed by Epcot and Hollywood Studios July 15. Last week, Universal Orlando presented its plan to reopen June 5. That plan also has been approved by the Orlando task force, which sent its recommendation to the governor.

The parks will reopen with limited capacity, but officials didn't specify the number of guests who would be allowed in initially. The company said attendance will be managed through a new system that requires advance reservations for park entry.

#### US priest McGivney being considered for sainthood

The founder of the Knights of Colombus, the influential U.S.-based lay Catholic organization, is moving a step closer to possible sainthood.

Pope Francis has approved a miracle attributed to the intercession of the Rev. Michael McGivney, a Connecticut priest who died at age 38 of pneumonia in 1890 during a pandemic similar to the current coronavirus outbreak.

He would be the first U.S. parish priest to be beatified, the first major step before canonization.

The Vatican said Wednesday that Francis had signed off on the miracle required. The Knights said it concerned the medically inexplicable cure of a baby with a life-threatening condition who was healed in utero in 2015

#### 'Honor killing' of teen girl in Iran causes outcry

The so-called "honor killing" of a 14-year-old Iranian girl by her father, who reportedly used a farming sickle to behead her as she slept, has prompted a nationwide outcry.

Reza Ashrafi, now in custody, was apparently enraged when he killed his daughter Romina last week after she ran away with 34-year-old Bahamn Khavari in Talesh, some 198 miles northwest of the capital, Tehran.

In traditional societies in the Middle East, including Iran, blame would typically fall on a runaway girl for purportedly having sullied her family's honor, rather than on an adult male luring away a child.

Romina was found five days after leaving home and taken to a police station, from where her father brought her back home. The girl reportedly told police that she feared a violent reaction from her father.

On Wednesday, a number of national newspapers featured the story prominently and the social media hashtag #RominaAshrafi has been used thousands times on social media, with most users condemning the killing.

#### Police arrest 26 people in truck deaths of Vietnamese


Police in Belgium and France on Wednesday announced the arrests of 26 people suspected of human trafficking in the deaths of 39 Vietnamese migrants whose bodies were found in a refrigerated truck in Britain last year.

Judicial authorities said a series of early morning raids took place simultaneously in Belgium and France on Tuesday as part of two legal investigations.

One inquiry was launched following the investigation into the deaths of the 39 migrants found in October inside a truck's refrigerated container that had been hauled to England. Police investigating the case found the 31 male and eight female victims were all from Vietnam and ranged in age from 15 to 44, including three minors. Police said migrants died from a combination of a lack of oxygen and overheating in an enclosed space.

# <u>NOTICE OF</u> <u>PROPOSED MAJOR</u> <u>UTILITY FACILITY</u>

Pursuant to Ohio Administrative Code ("OAC") Rule 4906-3-09(A)(2), The Ohio State University is notifying you of a proposed combined heat and power ("CHP") major unit facility to be located on the campus of The Ohio State University in Franklin County, Ohio, as shown in the map below. This notification is part of a standard process required by the Ohio Power Siting Board ("Board") prior to planned public hearings


The CHP facility will produce thermal energy powered by natural gas while introducing electricity generation on campus and will serve as a primary source of heating and electricity to the Columbus campus. The heating capacity of the CHP facility will be 285 klbs/hour of superheated steam. The CHP facility will have a nameplate maximum output capacity of 105.5 MW and will include the installation of two natural gas combustion turbine generators and one steam turbine generator.

An application for a certificate to construct, operate, and maintain said facility is now pending before the Board and has been assigned Case No. 19-1641-EL-BGN. The Board has established the dates for the public hearing. The public hearing shall consist of two parts and will be conducted by telephone and live video on the internet:

- (a) A public hearing, pursuant to R.C. 4906.08(C), where the Board shall accept testimony from any person, commencing on June 30, 2020, at 6:00 p.m., where the public will be given an opportunity to comment on the proposed facility.
- (b) An adjudicatory hearing to commence on July 14, 2020, at 10:00 a.m.

The local public and adjudicatory hearings will both be held using remote access technology that facilitates participation by telephone and/or live video on the internet.
