FINDING AND ORDER

Entered in the Journal on June 3, 2020

I. SUMMARY

{¶ 1} The Commission approves the applications in the above-captioned proceedings to revise XO Communications Services, LLC's intrastate access tariffs.

II. DISCUSSION

{¶ 2} Pursuant to Ohio Adm.Code 4901:1-6-25(D), a telephone company may not cease offering any services required to be tarified pursuant to Ohio Adm.Code 4901:1-6-11 without first filing an application to withdraw such services from its tariff pursuant to a TP-UNC filing.

{¶ 3} On April 7, 2020, as amended on May 22, 2020, XO Communications Services, LLC (XO or Applicant) filed an application in Case No. 20-717-TP-UNC (20-717) to revise its Intrastate Access Services Tariff (P.U.C.O. Tariff No. 3) by withdrawing special access services.

{¶ 4} On April 7, 2020, as amended on May 5, 2020, and May 22, 2020, XO filed an application in Case No. 20-718-TP-UNC (20-718) to revise its Intrastate Access Services Tariff (P.U.C.O. Tariff No. 4) by withdrawing dedicated access services. The Applicant states that there are no existing customers subscribing to these services.

{¶ 5} Staff filed its review and recommendation in each of these cases on May 27, 2020, noting that XO has indicated that there are no existing customers subscribing to the services addressed in Case Nos. 20-717 and 20-718. Staff believes that the applications appear to satisfy the requirements set forth in Ohio Adm.Code 4901:1-6-25(D), and, therefore, recommends that they be approved.

{¶ 6} Upon further review, the Commission determines that the applications to revise XO's tariffs in the above captioned cases should be approved. In reaching this determination, the Commission notes that there are no existing customers subscribing to the impacted services. As a result, the Commission concludes that customer notice is not required to be provided.

III. ORDER

{¶ 7} It is, therefore,

{¶ 8} ORDERED, That the applications filed in the above-captioned cases be approved. It is, further,
