## Inmate accused of possessing illegal narcotics in jail

Felony drug charges are pending against a Cambridge man incarcerated in the Guernsey County Jail after corrections officers found suspected cocaine and marijuana in his cell Wednesday night.

The inmate is accused of using a mask provided to assist with preventing the spread of COVID-19 coronavirus to help conceal some of the suspected narcotics while he was being booked into the Southgate Parkway facility.

The male, identified as Clifton Hamilton, 40, was booked into the county jail on May 21 on a

capias issued by the Guernsey County Common Pleas Court after he failed to appear for a pre-trial hearing. He was indicted on March 18 on one count of possession of cocaine, a fifth-degree felony.

The suspected narcotics were seized as evidence and will be sent to the Ohio Bureau of Criminal Identification and Investigation for testing.

Hamilton was also recently indicted by the Guernsey County grand jury on unrelated charges of aggravated possession of drugs, a third-degree felony; tampering with evidence, a third-

degree felony; two counts of possession of cocaine, fifth-degree felonies; and two counts of aggravated possession of drugs, fifth-degree felonies.

According to reports at the Guernsey County Sheriff's Office, a deputy was requested in the jail at 9:20 p.m. after corrections officers acting on a tip reported finding a small plastic bag containing a green, leafy substance believed to be marijuana and a plastic bag containing a white substance suspected to be cocaine in the pod where Hamilton is housed.

The suspected narcotics were

reportedly concealed under a table in the cell.

Video surveillance from the night Hamilton was booked into the county jail last week reportedly showed he was concealing an object believed to be one of the bags of drugs in his clenched left hand. The video also reportedly showed Hamilton conceal an item believed to be one of the bags containing illegal narcotics inside his mouth behind the face mask.

Images from a body scanner at the jail reportedly showed something the same size and shape as the baggie of suspected cocaine



in Hamilton's left hand and it appeared Clifton Hamilton had something in his mouth.

Hamilton and other inmates were interviewed regarding the suspected narcotics. Hamilton denied the suspected drugs belonged to him or that he brought them into the jail.

Investigators are seeking two counts of illegal conveyance of drugs against Hamilton.

No other information was available. Hamilton remained incarcerated in the county jail as of press time Thursday.

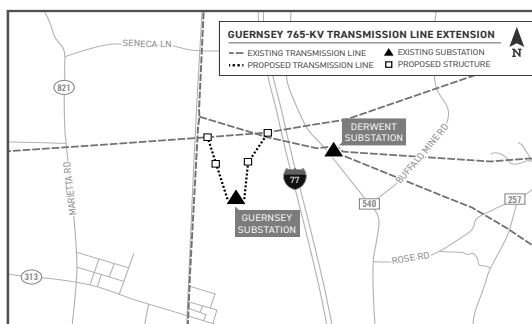
