MEMORANDUM IN SUPPORT OF APPLICANT'S MOTION FOR EXTENSION OF CERTIFICATE

Applicant TruEnergy Services, LLC filed its Renewal Application for Competitive Retail Natural Gas Supplier, Certificate No. 18-661G(1), on June 8, 2020. However, Applicant's current Certificate expired on June 7, 2020. Applicant's office was closed due to the COVID 19 pandemic, and Applicant inadvertently failed to file its renewal application in the timelines set forth in OAC Rule 4901:1-27-09. Pursuant to OAC Rule 4901:1-27-04, any gas supplier that fails to file an application for certification renewal prior to the expiration date on the certificate must file a new application and "may request, no later than sixty days after the expiration date on the certificate, to extend its previous certificate during the pendency of the new application review." Accordingly, TrueEnergy now files this Motion for Extension of its Certification pursuant to OAC Rules 4901:1-27-04 and 4901:1-27-07. Further, Applicant is now filing a new application for competitive retail natural gas provider with the Commission, and requests that Certificate No. 18-661G(1) be extended while its new application is being processed.

There are no other parties to this proceeding so there are no other competing interests for the Commission to weigh in considering this motion. Further, Applicant appreciates the importance of filing applications for renewal of its certificate timely and in accordance with OAC 4901:1-27 in the future. Respectively, Applicant submits that this motion is well-made and should be granted. Applicant's new application for competitive retail natural gas provider is being submitted in a new case.

WHEREFORE, TruEnergy Services, LLC respectfully requests that this Motion for Extension of Certificate, Certificate No. 18-661G(1), be granted for the reasons set forth herein.
