Dear Ms. Troupe:

On June 16, 2020, tariff pages for the Ameritech Operating Companies were filed with the Federal Communications Commission ("FCC") under Transmittal No. 1888. This filing in the F.C.C. No. 2 Tariff became effective on July 1, 2020.

With this filing, Ameritech will revise the Universal Service Fund (USF) factor to calculate the 3rd Quarter 2020 USF obligations and update line counts used in the calculation of the Federal Universal Service Fund (FUSF) recovery charges billed to residential and business customers.
