Enclosed for filing is the Duke Energy Ohio ("Duke") gas cost recovery (GCR) report, as required by Section 4901:1-14, O.A.C., for the month commencing August 2020. This filing is based on supplier tariff rates expected to be in effect on July 30, 2020 and the NYMEX close of July 7, 2020 for the month of August 2020.

Duke's GCR rate effective August 2020 is \$2.727 per MCF, which represents an increase of \$ 0.129 per MCF from the current GCR rate in effect for July 2020.
