Dear Ms. White and Ms. Troupe:

This letter serves as the Pre-Application Notification Letter to the Ohio Power Siting Board ("Board") of Powell Creek Solar, LLC's ("Applicant" or "Powell Creek") application for its proposed solar-powered electric generating facility.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-3-03(A), Applicant provides the following information:

- **Project Description.** Powell Creek is proposing to develop, construct, and operate a 150 megawatt ("MW") solar-powered electric facility in Liberty and Palmer Townships, Putnam County, OH. The Applicant expects to file its application to the Board in August 2020. Construction of the Project is expected to begin in late 2021, with commercial operations in 2022.
- Pre-Application Public Informational Meetings. In accordance with Powell Creek's May 29, 2020 motion for limited waiver and the Board's June 16, 2020 entry, Powell Creek will be holding a web-based and teleconference Public Information Meetings. The Applicant plans to hold an approximately two-hour web-based Public Information Meeting on July 29, 2020 at 6:30 p.m. The Applicant will also hold an approximately two-hour-long teleconference session on July 30, 2020 at 6:30 p.m.

• **Anticipated Waivers.** Based on the information currently available, the Applicant anticipates requesting a waiver with regards to OAC 4906-4-08(A)(1)(c) and OAC 4906-4-08(D)(2)-(4). The Applicant reserves the right to request additional waivers if necessary.
