

The following represents a Supplement to fares for the 2020 season for travel between Port Clinton, OH on the mainland – South Bass Island (Put-in-Bay), Ohio in Lake Erie an EMERGENCY MASK FARE of \$1.00. This fare represents a new category of fares previously expressed in the PUCO 35.

Starting 07/07/2020, the Jet Express will be requiring ALL passengers to wear a mask or face covering while ONBOARD our vessels.

- We strongly recommend that you bring your own mask with you.
- If you do not have a mask with you, you may purchase one from our ticket window for \$1.
- You will be required to wear a mask while onboard our vessels where social distancing may not be possible.
- Masks are not required, but recommended, on our docks or in Island Port if appropriate distancing measures are followed.
- Children ages 6 and younger are exempt from this policy.
- People with disabilities, mental health conditions, or medical conditions which would restrict their ability to wear a mask are exempt from this policy.
