Pursuant to Rule 4906-3-03(A) of the Ohio Administrative Code, Grover Hill Wind, LLC ("Applicant") files this Second Preapplication Notification Letter with the Ohio Power Siting Board ("Board") regarding its proposed wind-powered electric generation facility. The proposed facility will be located in Paulding County, Ohio. The wind facility is expected to have a maximum total generating capacity of up to 150 megawatts. The purpose of the Grover Hill Project is to generate electricity and its anticipated function is to supply renewable energy.

The public information meeting has been rescheduled as follows:

- 1. The Applicant anticipates filing its application with the Board within 90 days after the public information meeting. Construction of the Grover Hill Project is estimated to begin in the first quarter of 2021, resulting in commercial operations in the fourth quarter of 2021.

At this time, the Applicant does not anticipate that it will be filing any requests for waiver from the Board's rules regarding the electric generation facility.
