Dear Ms. White:

After working for nearly 14 years to address a critical need for energy infrastructure in the region, local jurisdictions led by Logan, Madison and Union counties, formed the Ohio Gas Access Partnership (OGAP) in early 2019 to find a solution for the long-term energy needs of their communities.

In late December of 2019 Columbia Gas filed an application with the Ohio Power Siting Board to construct the Marysville Connector, a 4.78 mile, 12 inch natural gas pipeline to service new industries and residential development southeast of Marysville in Jerome and Millcreek Township. Throughout the application process OGAP communicated with Columbia Gas to express concerns and ensure that the Marysville Connector is part of a long-term regional plan to the long standing need for natural gas in the area. OGAP and its members were able to get answers to the concerns we had in the filing and we believe the project is in the best interests of the public.

On July 21, 2020 the OGAP Executive Board voted unanimously to support the Marysville Connector Pipeline Project and encourages the Ohio Power Siting Board to approve the application (Case Number: 19-2148-GA-BLN).
