{¶ 1} On September 24, 2019, Staff served a notice of apparent violation and intent to assess forfeiture upon Caleb Salyers (Respondent), alleging a violation of the Commission's transportation regulations.

{¶ 2} On December 13, 2019, the Commission received an email from Respondent, wherein Respondent requested that his case be reopened. The attorney examiner, at that time, recognized Respondent's correspondence as a request for an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.

{¶ 3} The attorney examiner scheduled this matter for a prehearing conference on January 28, 2020. The parties did not resolve this matter at the prehearing conference.

{¶ 4} On February 10, 2020, the attorney examiner issued a prehearing motion calendar and scheduled this matter for hearing on March 27, 2020.

{¶ 5} Consistent with the prehearing motion calendar, Staff filed a motion to dismiss the case on February 27, 2020. Also within the time provided by the attorney examiner, Respondent served a request for waiver of certain Ohio Adm.Code Rules upon Staff on March 9, 2020, which was electronically filed on behalf of Staff on June 11, 2020.

{¶ 6} On March 13, 2020, due to scheduling conflicts at the Commission and in order to provide time to review the respective positions of the parties as described in their written pleadings, the attorney examiner postponed the hearing scheduled for March 27, 2020.

{¶ 7} The attorney examiner now reschedules the hearing in this case for October 27, 2020, at 10:00 a.m. The hearing will occur using remote access technology. Additional

details and instructions regarding remote access to the evidentiary hearing will be provided to the parties within a reasonable time period prior to the hearing

{¶ 8} It is, therefore,

{¶ 9} ORDERED, That the hearing in this case be scheduled on October 27, 2020, as stated in Paragraph 7. It is, further,

{¶ 10} ORDERED, That a copy of this Entry be served upon all parties of record.
