P.U.C.O. No. 2 Tariff for Gas Service

UNCOLLECTIBLE EXPENSE RIDER

Applicable to all volumes served under the General Service (Sheet No. 9) and Transportation Service (Sheet No. 10) rate schedules. An additional charge shall be applied to all volumes for service rendered to recover costs associated with uncollectible accounts arising from those Customers responsible for paying the Uncollectible Expense Rider. The Company shall file an application with the Public Utilities Commission of Ohio requesting approval to change the rate if the Company determines that an adjustment of more than plus or minus ten percent (10%) is needed to adjust for prior period over- or under-collections. In addition to the periodic update and reconciliation process, the Uncollectible Expense Rider may also include Customer refunds if the Commission or Supreme Court of Ohio determines, as a result of the Commission's biennial audit of the rider, that the Company's Uncollectible Expense Rider was unlawful or unreasonable or included imprudent amounts. The current Uncollectible Expense Rider rate is \$(0.0004) per Mcf.
