**JOINT MOTION FOR CONTINUANCE AND AMENDED PROCEDURAL SCHEDULE
AND REQUEST FOR EXPEDITED TREATMENT**

In accordance with Ohio Adm.Code 4901-1-12(A), 4901-1-13(A), 4901-1-14, and 4901-1-27, The East Ohio Gas Company d/b/a Dominion Energy Ohio (DEO or the Company) and The Staff of the Public Utilities Commission of Ohio (Staff), as joint “Movants,” respectfully request a continuance of the deadline for expert testimony and the date for the evidentiary hearing in this matter. Pursuant to Ohio Adm.Code 4901-1-12(C), Movants also request an expedited ruling on their motion.

As established by the May 27, 2020 Entry in this proceeding, a hearing is scheduled to commence on August 17, 2020, and the deadline for the filing of expert testimony is scheduled for August 10, 2020. Movants request that the hearing be continued to 10 A.M. on September 14, 2020, and the deadline for the filing of expert testimony be moved to August 31, 2020. Movants make this request so that the parties to this proceeding, who have been engaged in settlement discussions to resolve the issues, may have more time to continue said discussions.

Movants have conferred with counsel for the Office of the Ohio Consumers’ Counsel (OCC) and Northeast Ohio Public Energy Council (NOPEC), the only organizations to have filed motions to intervene in this proceeding. Neither OCC nor NOPEC objects to Movants’ proposal or the request for an expedited ruling.

WHEREFORE, Movants respectfully request that the Attorney Examiners issue an Entry that amends the procedural schedule in this matter consistent with Movants’ proposals herein.
