I WAS AT THE INSTITUTE FOR ORTHOPAEDIC SURGERY FOR KNEE REPLACEMENT. I WAS AT I.O.S. THREE DAYS AND FOUR DAYS AT A NURSING HOME. THEY DID NOT HAVE THE EQUIPMENT THEY CLAIMED TO HAVE SO MY SURGEON SENT ME HOME. I WAS TO START REHAB AT I.O.S. ON MONDAY, WEDNESDAY-FRIDAY AFTERNOONS.

THAT MONDAY MORNING WITH MY METAL WALKING AID I MADE MY WAY TO A LAWN CHAIR, JUST AS I GOT THERE A BIG DIESEL DUMP TRUCK LEFT MY PROPERTY LOADED WITH DIRT, THAT TRUCK COULD EASILY CARRY TEN TONS OF DIRT. I TRIED TO GET THE LICENSE NUMBER BUT IT WAS COVERED WITH SOME GLOPSOE I COULD NOT READ IT, BUT I SAW A PICKUP WITH DOMINION ENERGY ON THE DOOR, I MADE MY WAY TO THE PICKUP, I ASK THE GUY WHO HE WAS, HE SAID HE WAS THE OVERSEER. I ASK HIM WHERE THAT DUMP TRUCK WAS TAKING ALL MY DIRT, HE SAID BECAUSE THERE WAS SO MANY TREES THEY COULD NOT PILE THE DIRT THEY WERE STORING IT, HE SAID THERE WOULD BE MORE LOADS WOULD BE STORED AND RETURNED AT THE END OF THE JOB.

NO DIRT WAS RETURNED, EXCEPT THE DIRT RELATIVE TO THE THREE BIG HOLES NEAR TO THE ROAD, A GAFFRY ISSUE WHICH THE SHAWNEE POLICE REQUESTED DOMINION FILL.

P.U.C.O. CINDY MACK - CASE #00161-472 SAID SHE WOULD CLOSE THE CASE BECAUSE DOMINION ENERGY CLAIMED THEY WERE ON MY PROPERTY IN 2014, NOT 2017. DOMINION ALSO CLAIMED BUCKEYE PIPELINE DONE ALL THE DAMAGE TO MY PROPERTY BOTH CLAIMS ARE NOT TRUE. MRS MACK MUST KNOW DOMINION WAS NOT FACTUAL BECAUSE MY CASE WOULD BE DATED IN 2017, NOT 2014. MRS MACK SAID SINCE DOMINION CLAIMED BUCKEYE DONE THE DAMAGE TO MY PROPERTY I WAS TO CALL FEDERAL P.H.M.S.A. AT 1-202-366-4831; JAN WOODS WAS TO INVESTIGATE, HIS CELL #PH-1-609-468-9478, HE NEVER RETURNED MY CALLS.

SHAWNEE TSP POLICE DEPT. 419-227-1115, I WENT TO THEM WHEN DOMINION DID NOT RETURN THE DIRT TO MY PROPERTY OR FILL THOSE THREE BIG HOLES TWO WERE EACH 8 FT LONG X 4 FOOT WIDE BY FIVE FEET DEEP AND ONE WAS 6 FT LONG X 4 FT WIDE AND 5 FEET DEEP. THE POLICE SAID CALL P.U.C.O. BUT THE ~~THE~~ THREE HOLES WAS A SAFETY ISSUE AND THEY NOTIFIED DOMINION TO FILL THE HOLES WHICH DOMINION DID, BUT DID NOT BRING BACK THE 60 OR MORE TONS OF DIRT.

A LADY, SHE SAID SHE WAS (75) YEARS OF AGE DRIVING A DOMINION P.U. TRUCK SAID DOMINION MGMT CLAIMED SHE ^{WAS} AT MY PROPERTY IN 2014 NOT 2017 THE LADY SAID I KNOW I WAS AT YOUR PROPERTY IN 2017 I MARKED THE PIPELINE, THEY WAS TO REPLACE ON MY PROPERTY SHE SAID ONLY 80 FEET OF PIPELINE WAS TO BE REPLACED, DOMINION'S OVERSEER SAID THEY HAD A LOT OF PIPELINE TO REPLACE. THE LADY SAID THE 80 FEET OF PIPELINE WAS IT, AND THERE WAS NOT ANY OTHER PIPELINES ON MY PROPERTY - THE ONLY PIPELINES WERE NEAR THE

Dominion Energy has taken at least 60 tons of top soil and dirt from my property. It has done away with a ditch that took the run off from the road and my property. It also created a trough about 20 feet wide, which dropped about 2½ feet from the east property line to my home.

At that time we had two storms. My home was flooded twice.

I called Dominion many times about bringing back all the dirt. Their overseer said all the dirt would be returned as soon as they got this pipeline replaced. Of course, they never came back. A person who worked for Dominion later told me the dirt was used for landscaping at Dominion's new building on Jackson Street.

They also dug three holes near the road. I went to Shawnee police about this problem. They called the PUCO about three holes that was left in my yard and was a safety issue. Soon Dominion started to fill them. Dominion now claims it was Buckeye pipeline that dam-

aged my property and home.

I'm 85, my wife is 87. The house now has holes in the floor and some floor joints have given away.

When all this trouble began in April 2017, I had just had a knee replacement and couldn't get out to see what they were doing.

If you know of a lawyer, I need one.
