HARDIN WIND ENERGY, LLC'S RESPONSE TO THE SECOND DATA REQUEST AND SECOND SUPPLEMENT TO THE FIRST DATA REQUEST FROM THE STAFF OF THE OHIO POWER SITING BOARD

Hardin Wind Energy LLC ("Hardin Wind") was certified by the Ohio Power Siting Board ("Board") to construct the Hardin Wind Farm, a wind-powered electric generation facility to be located in Hardin County, Ohio, in accordance with the Certificate of Environmental Compatibility and Public Need issued by the Board in Case No. 09-479-EL-BGN, as amended in Case Nos. 11-3446-EL-BGA, 16-469-EL-BGA, 16-2404-EL-BGA, and 18-677-EL-BGA ("Certificate"). On July 17, 2020, Hardin Wind filed notice of relinquishment and withdrawal of its Certificate with Board.

On August 11, 2020, the Staff of the OPSB ("OPSB Staff") provided the Hardin Wind with OPSB Staff's Second Data Request. Now comes the Hardin Wind providing the following response to the Second Data Request from the OPSB Staff, as well as the Second Supplement to the Response to the First Data Request from OPSB Staff filed on August 7, 2020.

1. Please describe the extent of wind farm construction and decommissioning activities at T18 which is located at latitude 40°40'45.99"N, longitude 83°49'42.58"W.

Response: No construction was done at the T18 site, because during excavation water sprouted up. The area was immediately backfilled. Therefore, decommissioning was not necessary.

2. Please explain if there are any geological and/or geotechnical issues, including but not limited to karst topography, that are present at any reclamation site.

Response: There are no geological or geotechnical issues, including issues pertaining to karst topography, present at the reclamation sites.

3. Supplement to Response to OPSB Staff's First Data Request.

Response: Attached please find a letter from the Hardin County Commissioners stating that they have no issues with the request for relinquishment.
