



For example, for flat rate local service, using rates in effect prior to 9/1/2020; the rate is calculated and shown on the bill as follows:

Customer bills display a Line Charge of \$18.70, which is a combination of the network access line rate (\$16.40) and the central office termination rate (\$2.30), as well as an Unlimited Residence Service (flat rate usage) rate of \$7.55. As a result of the 9/1/2020 rate increase, the tariffed rate for a flat rate residential network access line will increase by \$2.00, going from \$16.40 to \$18.40. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$18.70 to \$20.70.
