You were previously notified that the rate for Flat Rate Service would increase \$2 effective 5/1/2020. Due to the COVID-19 pandemic, this rate change was delayed. The monthly rate for residential Flat Rate Service will increase by \$2 on 9/1/2020. Customers with certain packages and bundles will not be affected by the increase. **Note:** A residential customer's local exchange service consists of three tariffed components: a network access line, a central office termination and usage. However, these three tariffed components are displayed as two charges on the customer's bill, a Line Charge and a Usage Charge. For example, for flat rate local service, using rates in effect prior to 9/1/2020; the rate is calculated and shown on the bill as follows:

Network Access Line	\$16.40	}	Displayed as \$18.70 "Line Charge" on the bill.
Central Office Termination	\$2.30		
Flat Rate Usage	\$7.55		Displayed as "Unlimited Residence Service" charge on the bill.
Total	\$26.25		

Customer bills display a Line Charge of \$18.70, which is a combination of the network access line rate (\$16.40) and the central office termination rate (\$2.30), as well as an Unlimited Residence Service (flat rate usage) rate of \$7.55. As a result of the 9/1/2020 rate increase, the tariffed rate for a flat rate residential network access line will increase by \$2.00, going from \$16.40 to \$18.40. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$18.70 to \$20.70. So, for flat rate local service, using rates in effect subsequent to 9/1/2020, the rate will be calculated and shown on the bill as follows:

Customers affected by the rate increase will see their bill for flat rate local service increase from \$26.25 (\$18.70 + \$7.55) to \$28.25 (\$20.70 + \$7.55).
