

**MEMORANDUM IN SUPPORT OF REQUEST
FOR EXTENSION**

On August 16, 2020, Energy Professionals, LLC's ("EPROS" or "Movant") Certification as a Competitive Retail Electric Service Provider expired. On August 27, 2020, EPROS submitted a renewal application pursuant to Ohio Administrative Code section 4901:1-27-09.


EPROS requests that the Public Utilities Commission of Ohio ("PUCO" or "Commission") grant an extension of the expiration date of its Certificate Number 12-553E(4), from August 16, 2020 to September 30, 2020, while the renewal is pending with the Commission.

Rule 4901-1-13(A) of the Ohio Administrative Code permits parties to move forward for extensions of time to file pleadings or other papers and that these may be granted upon motion of any party for "good cause shown." Movant seeks an extension of its Certificate from August 16, 2020 to September 30, 2020, pursuant to the Rule because such an extension will allow for its customers' service to not be interrupted while its renewal is pending. Moreover, Movant is managerially, financially, and technically fit, and capable of both providing the intended services and complying with the Commissions' rules and orders.

WHEREFORE, for the above reasons EPROS requests the Commission to grant its motion for extension of its Certificate for the time period the renewal is being reviewed by the Commission.
