#### MEMORANDUM IN SUPPORT

On September 10, 2020, the Office of the Ohio Consumers' Counsel ("OCC") filed a Motion requesting the Public Utilities Commission of Ohio ("Commission") to reject the interim update to the Tax Savings Adjustment Rider ("Rider TSA") of Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company ("Companies"). Counsel, who works from home in accordance with his employer's precautions to prevent spread of COVID-19, attempted to file the Companies' Memorandum Contra at approximately 4:00 p.m. on the September 25, 2020 deadline, well within the timeline allowed by Ohio Admin. Code 4901-1-12(B)(1). As a result of home Internet problems, however, transmission of the Companies' Memorandum Contra into the Commission's e-filing system was not successful until 11:29 p.m.

The response period for the Companies' Memorandum Contra is not mandated by statute. Therefore, under Ohio Admin. Code 4901-1-38(B), the Commission may waive the deadline for good cause shown. Counsel's home Internet problem is good cause.

Waiver will not cause prejudice to OCC. Under Ohio Admin. Code 4901-1-12(B)(2), OCC's reply period did not begin to run until it had received service of the Companies' Memorandum Contra to Reply, which followed successful completion of e-filing on September 28, 2020. Indeed, OCC filed its Reply on September 30, 2020, well

within the time established by the Commission's rule. This brief, one business day delay in e-filing will not in any way prejudice OCC or unduly prolong this proceeding and the Commission's consideration of the matters raised by OCC's Motion. Therefore, the Companies hereby request the Commission accept their Memorandum Contra pursuant to this Motion. Again, granting this Motion will not violate any provisions of the Ohio Revised Code.

For the foregoing reasons, the Companies respectfully request that the Commission grant its Motion for Leave to File Out of Time.
