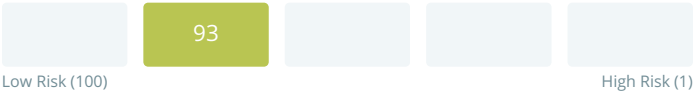

FINANCIAL STRESS SCORE



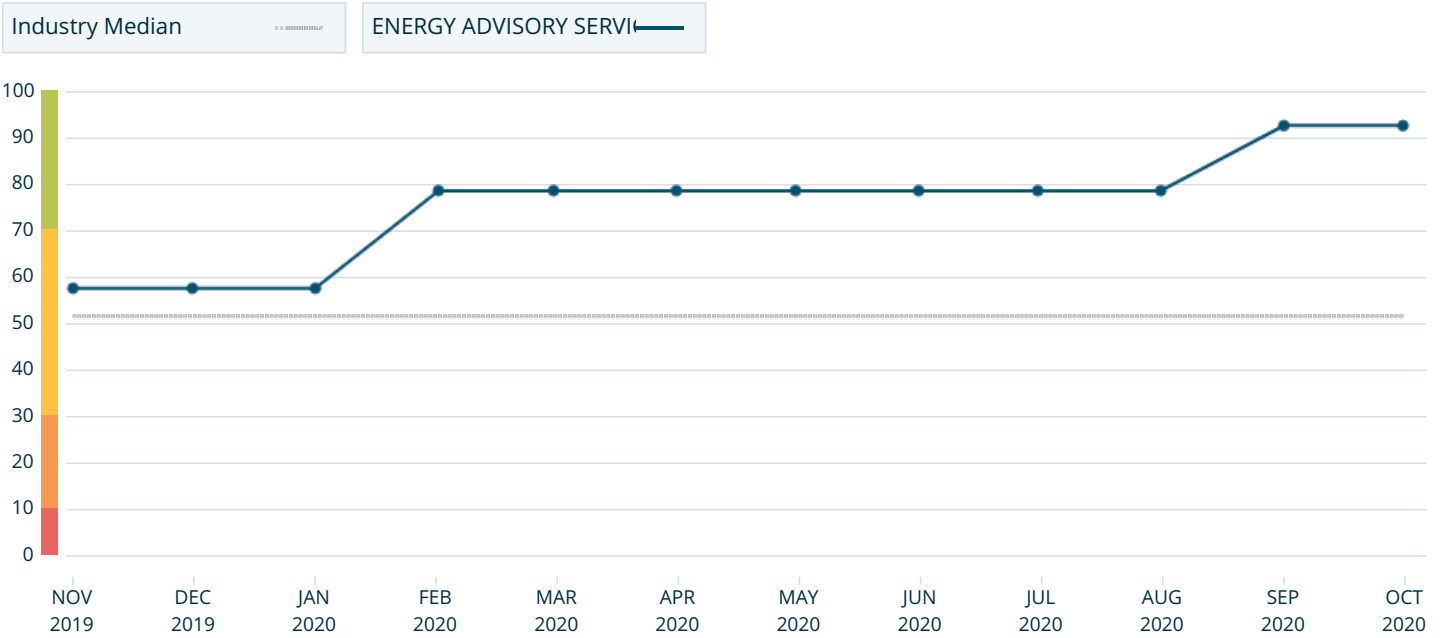

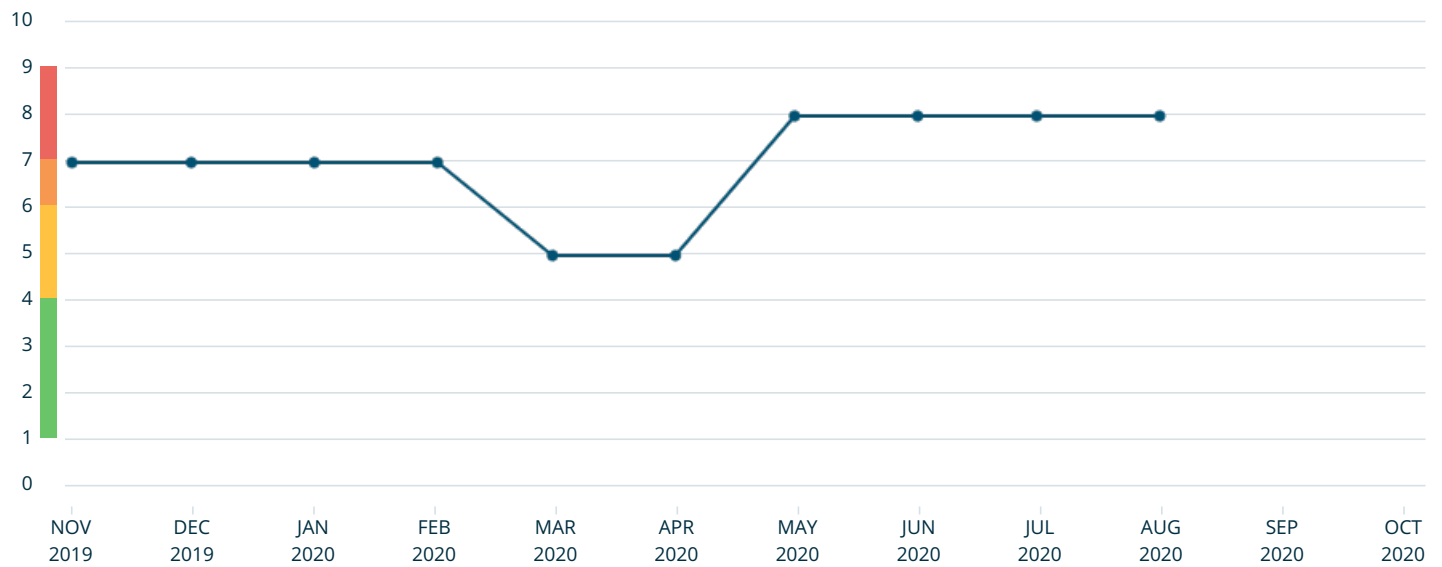
