## FINDING AND ORDER

Entered in the Journal on October 7, 2020

### I. SUMMARY

{¶ 1} The Commission finds that Certificate No. 16-SPV-KY-GATS-0268 should be revoked, and this case should be dismissed and closed of record.

### II. DISCUSSION

{¶ 2} R.C. 4928.64 and 4928.645 contain the renewable energy resource requirements for electric utility and electric services companies providing electric retail generation in Ohio. R.C. 4928.01(A)(37) defines the types of renewable energy resource generating facilities that qualify in meeting the statutory mandates.

{¶ 3} Pursuant to Ohio Adm.Code 4901:1-40-04(F), any entity that desires to be designated an eligible renewable energy resource generating facility for the state of Ohio shall file an application for certification that demonstrates the facility satisfies the requirements of R.C. 4928.64 and 4928.645.

{¶ 4} On February 16, 2016, Solar Energy Solutions, on behalf of Brian Parrish and Stephen George (Applicant), filed an application for certification as an eligible Ohio renewable energy resource generating facility at 3512 Ellemoor Court, Lexington, KY 40515 (Facility). The application submitted for certification the use of a solar photovoltaic system consisting of 30 roof-mounted modules at the 9-kilowatt Facility.

{¶ 5} On April 19, 2016, Certificate No. 16-SPV-KY-GATS-0268 was issued to the Applicant with an effective date of April 17, 2016.

{¶ 6} On September 22, 2020, correspondence from the Applicant was filed in this case wherein the Applicant requests that Certificate No. 16-SPV-KY-GATS-0268 be revoked.

{¶ 7} The Commission finds that the Applicant's request to revoke Certificate No. 16-SPV-KY-GATS-0268 is reasonable and should be granted.

### III. ORDER

{¶ 8} It is, therefore,

{¶ 9} ORDERED, That Applicant's request to revoke Certificate No. 16-SPV-KY-GATS-0268 be granted. It is, further,

{¶ 10} ORDERED, That Case No. 16-289-EL-REN be dismissed and closed of record. It is, further,

{¶ 11} ORDERED, That a copy of this Finding and Order be served upon all parties of record.
